INTRODUCTION/PURPOSE:

This item is to request the Council approve the Sebastopol Solid Waste Collection Services Annual Rate Adjustment by the City's Franchise Solid Waste Collector/Hauler, Recology Sonoma Marin (RSM). Annual rate adjustments are permitted upon City review and approval as per the provisions of the Franchise Agreement between the City and RSM.

It should be noted that separately occurring on the State level is California law SB 1383 which targets a 50 percent reduction in the landfilling of organic waste in 2022. This will have a distinct impact on and consideration for City finances. The SB 1383 issues are separate from the agreement with RSM discussed in this agenda report and an update to Council will be provided at a future meeting. The County and RSM are currently drafting language that will be proposed to all the cities for their consideration later in 2021. The proposed amendments being drafted by the County and RSM will allow retirement of the existing program and replacement with a fully compliant SB 1383 program that will subsequently be funded and administered through franchise agreements within each city. SB 1383 goes into effect January 2022 and it is anticipated that the subsequent agreement with RSM will go into effect July 1, 2022. This matter will be brought to Council at a future meeting when the proposed amendments are provided by the County.

BACKGROUND:

On December 16, 2008 the Council adopted Resolution 5723 and entered into a Franchise Agreement (Agreement) with a local solid waste collection and hauling firm, Redwood Empire Disposal, also known as "The Ratto Group". The Agreement covered solid waste, recyclable and compostable materials collection and street sweeping services. Subsequently, on September 19, 2017, the Council approved the assignment of the Agreement from Redwood Empire Disposal to RSM. The original Agreement was effective January 1, 2009 and is set to end by December 31, 2023. On June 16, 2020 Council approved an Annual Rate Adjustment schedule effective July 1, 2020 for services provided by RSM.

The City received a letter from RSM dated April 23, 2020 requesting an annual rate adjustment effective July 1, 2020. A copy of the letter is attached.

DISCUSSION:

Franchise Agreement Section 7.3 is titled "Adjustments to Maximum Collection Service Rates" which describes the fee elements and rate adjustment methodologies. In simple form, a "Refuse Rate Index", or RRI, is calculated and applied to several service components, such as Single-Family Dwelling, Multi Family Dwelling, or Commercial Collection service rates (typically per bin or level of service per month) based on several factors affecting costs such as fuel rates or landfill tip fees, for example.

The Franchise holder is required to apply to the City for potential rate adjustments based on complex formulas described in the Agreement, which must be timed to allow changes to be effective July 1 of a given year. RSM submitted their new proposed rate sheets and supporting calculations on their letter dated April 23, 2021 (proposed annual rate adjustments included in letter, attached). In addition to the regular rate adjustments, RSM included a newly developed list of services and associated rates not previously listed on rate charts.

Single family rate change for single cans weekly pick-up would range between 2.1-2.3% per month, with the actual monthly rate changes effectively in the range of 28 cents per month to \$1.53 per month; the most commonly used 32 gallon size would rise 52 cents per month. Commercial single can and bin weekly pick-up rates are requested to rise in the range of 0.8-1.0% per month. The actual monetary amount of the commercial single can and single bin increases between \$0.19 per month and \$6.38 per month; while the often used 4 cubic yard bin weekly pick-up would be increased by \$4.87 per month. A summary listing of the proposed rates as compared with current rates is shown in the table below.

The largest and notable rate increase comes from the Organics Processing Increase Component, which passes through fees from the County level, which range from 8.79 – 10.03%. However, due to reduction in City organics volumes and other factors, the rate increase that will effectively be applied to residential rates will be at 2.52%. There are newly developed rates for additional services based on customer needs and those are shown in the attached letter from RSM.

GHD reviewed the proposed rate adjustments and found them to be in accordance with the appropriately applied RRI calculations for the services provided by RSM to the City. It should be noted that GHD reviewed the most relevant rate adjustments, but not all of the more than 100 rate items listed in RSM's proposed rate adjustments schedule.

PUBLIC COMMENT:

As of the writing of this staff report, the City has not received any public comment. However, staff anticipates receiving public comment from interested parties following the publication and distribution of this staff report. Such comments will be provided to the City Council as supplemental materials before or at the meeting. In addition, public comments may be offered during the public hearing.

PUBLIC NOTICE:

This item was noticed in accordance with the Ralph M. Brown Act and was available for public viewing and review at least 72 hours prior to schedule meeting date. In addition, a Legal Notice was published May 31, 2021 to June 4, 2021 regarding the public hearing date, time and a brief description of the proposed rates.

FISCAL IMPACT:

None to City finances. The rate adjustments apply to residential and commercial customers.

RECOMMENDATION:

It is recommended that Council review and approve the Sebastopol Solid Waste Collection Services Annual Rate Adjustments by the City's Franchise Solid Waste Collector/Hauler, Recology Sonoma Marin.

Per section 7.3 of the franchise agreement, please find attached the proposed adjustments to Recology Sonoma Marin (RSM) service rates using the refuse rate index (RRI) for rates effective July 1, 2021 through June 30, 2022, as well as the supporting information. RSM Audited Financial Statements for FY2020 are attached in a .

In response to requests from customers, Recology has developed rates for certain services not previously listed on the rate charts. Pricing for these services is based on comparable pricing on the current rate sheet or Recology costs plus city fees, if comparable pricing is not available. These rates include:

- Commercial 20G cart once per week
- Additional Recycling Carts after first included cart
- Additional Recycling Bins after first included bin
- Additional Organic Bins after first included cart
- Additional Organic Bins after first included bin
- Additional Bin Replacement after one per year
- Overflowing Cart and Bin Charges
- Lock Service
- Compactor Cleaning
- Relocation & Trip Fee Charges for Debris Box
- Monthly Box Rental (if no collection in month)
