In sending the forwarded email to Adrienne @ Sonoma Villages my regret is that I didn't cc it to all of you, so I am forwarding it to you now.

Our concern has everything to do with safety for not only our kids and grandkids but the disabled folk, myself included. There is a pathway that is heavily used that runs right in front of our house to Ragle Park. We are concerned about the unaddressed reasons for homelessness, mainly mental health which brings with it a criminal element that is not the least bit desirable in, up until this point, a quiet neighborhood. Morris St is at least out of town a bit and not in our own backyard where our kids walk and bike to school and where there will be a great deal of foot traffic that will happen right in front of the Amerigas property proposed for this new project.

I have never heard of such a limited offer between government entities. It seems especially curious that the proffered funds and the escrow for the property are not only so close by date but that those dates are coming up way too soon for us to react in any meaningful way. It feels like we are being railroaded into deciding far too quickly about a project that will be a negative impact on our community.

I am also very displeased by the time limitations put on the public for comment. The fact that our neighborhood didn't get notice about the zoom meeting until the day of the meeting is unconscionable.
