To whom it may concern,

I am writing in regards to the liquor license appeal submitted by Lowell Sheldon, regarding Piala LLC (7233 Healdsburg Ave.)

I have personal experience with Lowell Sheldon which I believe to be relevant. He took large sums of money from my mother, calling the more than \$100,000 over about 2 years a "line of credit" for the restaurant which she paid in advance with no written agreement. I don't know how long this had been going on before I was alerted by her financial advisor in 2015.

My mother moved to Sebastopol in 2008, after the recent loss of both her son and husband to cancer. She was at the time 74-81 years old. She developed a serious drinking problem for the first time in her life.

When I became aware of this situation, I met with Sheldon to ask him to provide me with paperwork for their arrangement. I was met by a cold and dismissive response and was told that he would not be providing any receipts or paperwork as I requested. I also told him how concerned I was about my mother's drinking and asked if he would please ask his staff to not offer or encourage the alcohol. I told him I did not expect anyone to police her drinking but any help with this matter would be appreciated. Again, he was very dismissive and uncaring. I left that meeting feeling sad and frustrated. It was very clear to me that there was no emotional connection to her in any way, yet he seemed to have a clear conscience about taking money from her and seemed inconvenienced to talk to me.

I was unable to put a stop to this situation until I threatened him with an elder abuse charge and took my mother from the condo where she was living and moved her to a retirement community

in 2017. At the end of her time at the complex located behind Sheldon's restaurant, he was having open wine delivered to her door at 8:00 in the morning. Although I never pressed charges and he remained in business, the thoughtless and reckless nature of his behavior was the source of much pain for myself and my family. I have heard of his sexual harrassment and drug abuse and because of my experience with him, believe the accusations stated by his victims. His toxic behavior makes me believe that the city of Sebastopol would be avoiding future ethical and legal problems by standing behind those who have been traumatized by Lowell Sheldon.

I eventually stopped serving him around 2013 at The Underwood(though he wasn't formally 86'd I made it clear to him he wasn't welcome anymore)mostly because he was so incredibly disagreeable and made the rest of my clientele uncomfortable.

I've been in the restaurant/bar/winery business since 1991 and Lowell Sheldon remains one of the most disreputable individuals I have ever come across.

In closing, I would strongly recommend against granting the man a liquor license.

I believe that Lowell Sheldon should not be granted an alcohol license and here's why. I understand he has a long history of sexual abuse, but this is something entirely different that I believe is illegal as well.

My mother owned one of the condos on the Florence St. property where Lowell's Restaurant was located. She ate nearly 100% of her meals there. At the time, my father had recently passed away and she was having a struggle with her alcohol consumption. She would regularly drink a bit too much and also, due to her advanced age, (in her 80s), her judgment was often impaired. She has a lot of money, and Lowell was aware of this. He told her she could run a "tab" and charged her \$50,000.00 upfront, TWICE!!! After that, he would let her eat there and never once offered receipts or any evidence of how much she'd spent. When he said her first \$50,000 had run out, he did the same thing again. Is this even legal?

I believe my sister asked for receipts and he was unable to produce them. I also have a hard time believing that this could be a legal way of doing business.

Due to the sensitive nature of the circumstances and my mother being a very private person, I am leaving her name out of it. I just wanted to make you aware of possible illegal money transactions as well as sexual offenses.

Hi Kari, please share my letter with the Planning Commission staff and any relevant parties.

--

I wanted to reach out to you and the Planning Commission staff regarding the denial of Piala's PNC letter for their ABC license. It's my understanding that this is going to be in front of the Planning Commission soon at a public hearing, since Lowell Sheldon has appealed this decision. I plan to speak publicly as well but was hoping you'd hear me out on a personal level too.

I employ several of Lowell's former employees and sadly have also experienced his harassment first hand at Retrograde as a customer, and on a personal level. I am very concerned about him opening up another business in town (near a school, no less) with access to alcohol and being in a continued position of power that he has time after time abused. He repeatedly failed to uphold his duties as a business owner to protect his employees, as have his management and business partners. I know that work culture is led from the top down and Lowell has no interest in protecting his employees. He has a heavily-documented decade+ long history of sexual abuse, assault, harassment and clear workplace violations that have all involved alcohol, including giving alcohol to minors. He has profited financially from the abuse of others as this forced his previous business partners (Fern Bar, Handline, Khom Loi) to buy him out of his shares, earning him profits well over 6-figures. He has also been banned as a customer from these businesses for the abuse he has forced their employees to endure and used his position as a partner to manipulate them.

Before everything went public in [the Bohemian](#) and [SF Chronicle](#) last year, he had made inappropriate comments toward my employees and been a horrible customer for years. He would repeatedly "forget his wallet" and never return to pay for goods he pressured my employees into giving him, even though we have a strict policy against that. Multiple team members privately expressed concerns to me about him making them feel uncomfortable and making inappropriate comments to them, which was the final straw. We asked him not to come in anymore, which prompted him to call me late at night (I've never given him my cell number), email me repeatedly and have his family members and friends threaten me and my business. They sent me emails, messages on social media and plastered my business with negative reviews on Yelp (which I have since had removed thanks to their help). I know there is nothing that can be done about this by the PC, but it speaks to his character and the character of the people who choose to work with him. These are all huge red flags and further show he does not understand or respect boundaries. I fear retaliation again for speaking out against him but cannot allow him and his behavior to attempt to silence me.

As an employer, it is our legal responsibility to protect our employees from the very abuse he forced them to endure. I know first hand from employing his former employees that he has psychologically

traumatized them and fostered horrible work environments. Many of his former employees are afraid to speak out against him. As someone who is trying to foster a positive, trusting work culture, it is very hard to do so with what his employees have endured. There is no way for anyone to guarantee that he is not part of daily operations and I fear that with access to alcohol, this will again become the norm at his new business and continue to have a negative impact on youth, women and workers in our community. I fear for innocent employees who may not know his history or read the first-hand events of what he has done, as many Sebastopol workers come from all over Sonoma County to work in the service industry here. Most of my employees, for example, do not live in Sebastopol.

As a contributing community member, it is our responsibility to keep fellow members safe as much as we can control. You can help prevent future victims of workplace harassment by upholding the Planning Director's decision to deny Pinal and Lowell Sheldon the PNC letter they need to obtain an ABC permit. This might be one of the biggest decisions in front of you this year and I empower you to do the right thing. I appreciate your time.

Good morning,

My name is Natalia and I am from Graton. I am writing you in regards to whether an alcohol license ought to be granted to Lowell Sheldon. It is of my strong opinion that he should not be granted one. Lowell is a predator. In either 2016 or 2017, I had secured a job at Peter Lowells, however after two weeks on the job I was offered a position at Ramen Gaijin which I jumped. I found Lowell to be so creepy and off-putting. During my short stint at Peter Lowells, Lowell had a prolonged gaze, would walk and stand too close, and brush up against me, not necessarily in a sexual way, but he had plenty of room to avoid me. I made no complaint (except to perhaps my mother) and began looking for a new job. When working at Ramen Gaijin, Lowell frequented the restaurant. I would watch him make women extremely uncomfortable at the bar, he was always lurking over them or putting his face too close to theirs. If I were walking past him he would put himself directly in my path, and once while I was at the bar waiting for someone's drink order he leaned in behind me, pinning me against the bar and himself. Overall, that man is a creep. I always wondered why nobody said anything about his disgusting and downright rapey vibes. Then I saw Leah's statement about Lowell, and all the other women coming forward with their sexually abusive experiences they had with Lowell. It all became clear. Lowell was using his position of authority to sexually abuse women, and a tool he frequently used was alcohol. People like Lowell are not going to change, they do not see what they are doing as wrong, or they simply do not care. Granting Lowell the ability to utilize one of his preferred tools he uses to get women at their weakest moments is empowering an abuser, and it would be a damn shame. I know these are just accusations, and he has never been convicted of sexual assault, but waiting for a conviction before the community finally puts up safeguards for women against this predator would be such a disservice to every person who has ever been a victim of sexual assault.

Hello, my name is Aaron Purtill. I am a former employee of the now closed Peter Lowell's and a long time resident of Sebastopol.

I believe that Lowell Sheldon should not be responsible or have power at a business that serves alcohol. There is an undeniable pattern of abuse and inappropriate behavior by Lowell at his previous businesses, which was often fueled by alcohol. He has proven time and again that he will offend, apologize, and repeat. I believe it is a huge sign that all previous restaurants he was a partner in have bought him out and cut tie — this shows that they feel it is unsafe to their employees to keep him as a partner due to his patterned behavior. I also see a huge red flag that Piala has already publicly separated him from day to day operations; I believe they know who they are in business with and realize they are at risk from his behavior.

Lowell has been my friend for almost two decades. We met as university students in Seattle and I've watched him grow up. With a dedication, grit, and community ethic that I admire, he built three restaurants from the ground up in Sebastopol - businesses that employed hundreds of people; paid taxes; and pleased countless diners.

Those efforts required years of behind-the-scenes work: False starts. Stalled projects. Construction disasters. Razor-thin profit margins. The personal toll of running multiple businesses: On one's relationships, on families, and on one's own well-being.

Though Lowell won't have any supervisory role in Piala, I know he put his heart into planning the new project. I am very much looking forward to sampling the Georgian cuisine that will add a whole new flavor to the food palette of West County.

I'm not here to tell you that Lowell is a perfect person. He has certainly made mistakes. But he isn't the cartoonish villain that recent media coverage makes him out to be. I've personally seen Lowell be a good manager, a civic-minded employer, and a very generous member of the community, supporting numerous non-profits.

These past two years, he has faced a storm of public scrutiny, difficult private conversations, and severance from his existing businesses. By any measure, it's been an intense period.

In Lowell, I see someone who is working to learn from his flaws - in therapy, in restorative justice efforts - and in a number of other community projects.

Lowell is a native son who wants to apply his skills to support his young family, and a successful change in ownership will allow him to do that. While some would pick up and choose a new city - he truly loves Sebastopol and would like to do the work to repair his relationship with his hometown.

Good Morning Kari and Planning Commissioners of Sebastopol,

Thank you to you and the Planning Commissioners for receiving comments previously and not approving Lowell Sheldon's alcohol license.

As someone harmed by sexual abuse and assault as a child and adolescent, I write to ask you to ask consider to not approve this license again. As a customer of Lowell's for years, I got the sense that Sheldon was the owner by his posture, sense of entitlement, and predatory energy. While the food was delicious, I always hoped he would not be there. I took this as a sign of my own wounding and trauma at the time, rather than reaching for others who may have been impacted. For this I am deeply sorry. As someone who has dappled in worker and community organizing, I stand alongside workers who have been exposed to his power over them; having to choose the need to make a living over safety and dignity. As a mental health provider with youth in Sonoma County communities for the last eight years, I know that people have been through so much over the last 5 years in this county, in particular.

I ask you to reduce the harms that may fall upon this community if Sheldon were to be granted an alcohol license.

I wonder if there are any alternative ways Sheldon may be able to contribute meaningfully to this community. I wonder what transformative processes he may engage with, so that his own healing and that of the collective can begin. I wonder what resources have been offered to those who have been harmed by his sexual assault, and I wonder what they may be needing.

I wonder about the role of the Planning Commission. How do licenses, zoning and land use of the city contribute to more safety and dignity for workers and community members of all classes, races, ethnicities, genders, sexual orientations, and documentation statuses?

I don't know but I thank you for your expertise, and for your time in reading this.

Dear Ms. Svanstrom:

I am writing in support of letting Mr. Sheldon continue his plans to open his establishment, including obtaining a valuable liquor license. I want to be clear that I do not know this man nor have I ever eaten at any of his establishments. I have no economic or personal interest in him obtaining his liquor license.

Like most women, I have experienced sexual harassment personally throughout my life and I know how frustrating it is to move in environments dodging bad behavior/boundaries. That being said, I do not understand withholding a liquor license, as this sounds like arbitrary punishment for his past behavior. Did he commit a crime related to holding a liquor license?

While the complaints about him and his work environments are problematic it seems that he has acknowledged his mistakes and has owned his past immature behavior. I do not see the point of men recognizing and apologizing for their mistakes if it means nothing. Otherwise, there is no point to them showing contrition. I also do not believe people should be prevented from working/making a living. While clearly the women who he hurt are angry and believe he has not shown enough guilt (what is enough guilt and who decides the measurements?) - there comes a point where we need to move forward. If we do not believe in people changing, or moving on from their mistakes, then we should just exile them to some vacant island.

To me it would be best letting him move forward with his business plans. The best measure of his behavioral changes are: 1. If he is able to hire and retain high quality, happy staff, 2. If the public opts to give him a second opportunity, patronizing his establishment.

If we were to cancel every man who failed to act properly toward women and girls, every institution from govt to hospitality to religious establishments etc would be closed. I do not know anything about the situation other than from what I have read. But it comes down to if these women want to pursue criminal or civil cases against him that is one thing but short of legal cases directly related to his behavior we need to allow people, such as Mr. Sheldon, opportunities to move on, practice their art, and support his reintroduction to the community.

Hello,

My name is Casey Lanski and I am a resident of Santa Rosa. I first met Lowell Sheldon at my business in Sebastopol, Retrograde Coffee Roasters.

My personal recommendation is to deny Lowell's alcohol license. As an owner-operator in Sebastopol for over 5 years, I have come into contact with Lowell as well as those he has harassed and mistreated. We have/had professional relationships with these individuals, as well as the businesses working with Lowell.

When the accusations went public, I was shocked at the quick and presumptuous progress/healing that Lowell claims to have made on his own. Equally appalling was the lack of compassion and inaction by the companies where these allegations are based. Lowell has been removed from these companies, and my rhetorical question is: how could a conscious mind give him the license to an extensive haul of alcohol and grant him the opportunity to create a toxic culture where he can abuse more employees?

I do not think Lowell has realized his specific problems with alcohol/drug abuse, which are clearly documented in the recent press in 2021. Similarly, Lowell has not acknowledged his problematic workplace behavior, and the subsequent exodus from his business partnerships were done without recognition that harassment had occurred. It simply is not up to Lowell and his colleagues to decide the definition of harassment.

At Retrograde Coffee Roasters in 2019, Lowell was upset that he would not be allowed to have a cappuccino without providing payment. Being told there is no special treatment, he began to use body language and eye rolling as bad behavior, and retorted that he "knew the owners" as if to convey his power over my employees. This type of behavior is not uncommon in the service industry, but it is completely unacceptable that a "renowned" entrepreneur would treat another business, and its entire organization with disrespect.

It goes without saying that alcohol will exacerbate personal problems, and Lowell is no exception. I don't believe Lowell is planning a wholesome and community-minded business; that will serve as a space that supports women, workers, and survivors of assault. This community would be better served knowing that the accusations have been heard and we are listening to the collective message: we cannot allow Lowell to repeat history.

Dear City of Sebastopol Planning Commissioners and Planning Director,

The purpose of this letter is to respectfully ask that the Planning Commission reject the appeal of Denial of Alcohol Transfer and Alcohol Use Permit, for PIALA LLC. The Planning staff have provided defensible grounds for this denial based on corroborated reports. The community now looks to the Planning Commission to exercise your judgment and discretion, and refuse the applicant’s appeal.

As way of background, I retired to West County from a career in land use planning and entitlements where I worked for the public and private sectors across California. My profession exposed me to a plethora of multi-disciplinary professional challenges and during my career, I garnered best planning principles and practices based on tough lessons learned. I suspect that the City’s planning decision makers share some of those principles that are relevant to the matter before you.

A proposed project description is defined by verifiable facts, not last-minute assurances and empty promises that may not or cannot be fulfilled. Owner Lowell Sheldon claims he will not be involved in the operations of his business, suggesting that his established pattern of at-risk behavior will be mitigated. How can an owner be barred from his place of business, especially when allegations include after-hours

events with repeated instances of sexual harassment, assault and other inappropriate behavior, particularly in the context of alcohol use?

Conditions and mitigations placed on a project must be enforceable, and if the agency is unable to enforce such conditions of approval, the project must be judged by the facts sans mitigations. In this case, no one can ensure the community that Lowell Sheldon will not enter the premises of his business as Sheldon suggested, including after-work hours when much of his persistent unprofessional (e.g. the service of alcohol to minors), illegal (e.g. drug use) and abusive (e.g. sexual harassment) behaviors allegedly occurred.

In evaluating a project, look for trends. In reading Lowell Sheldon's letters to the community, it is apparent that he can own "making some of his employees feel uncomfortable". And the purported self-work that he pursued over the past few years presumably was about this seemingly minor transgression. However, Lowell Sheldon resolutely does not own the repeated instances of sexual harassment, assault, serving alcohol to minors, and other inappropriate behavior, and therefore it is unlikely that he has accomplished any authentic reform. Many of us have witnessed first-hand a reformed individual; that individual does not place themselves back into that same risk environment. Moreover, Sheldon dismisses the allegations in stating his decade-long behavior "did not meet the standards of today". This quote alone speaks for itself.

Address the actual problem. Previous business partners of Sheldon and survivors of his harassment have corroborated the risks to the community of Sebastopol. Sheldon himself asserts he will be removed from operations. An alcohol-serving environment owned by Sheldon with vulnerable workers from our community is the problem. The risk to workers, minors and other community members in an alcohol-serving business cannot be mitigated.

I trust the Planning Commission will use its discretion to deny approval of a license allowing Mr. Sheldon to engage in the sale and service of alcohol in the City of Sebastopol.

Dear Commissioner Svanstrom,

I am writing to ask you to DENY a liquor license to Lowell Sheldon for his planned wine bar at 7233 Healdsburg Ave. I live in the greater West County and am therefore not always aware of what's happening in Sebastopol, but I began hearing about Sheldon's sexual advances and thoroughly inappropriate behavior last spring.

After looking into the matter a bit more thoroughly and reading several newspaper articles about him I realize his behavior has gone beyond what I had heard about. At least 11 young women have come forward to tell their stories of a toxic working environment complete with lewd sexual innuendos and illegal drug use by their boss, Lowell Sheldon, both after and in some cases during the working day.

This is a man who regularly drank alcohol with his employees after hours. Even with an underage employee. He also appears to have used cocaine and in one instance tried to get one of his employees to consume mushrooms. This man clearly has no sense of boundaries, is thoroughly unprofessional and exhibits very poor judgment. Alcohol and poor judgment are well known to be a dangerous combination.


Surely the most despicable incident I read about involved his forcing himself onto a young woman and ultimately, without her consent, ejaculating in her mouth. This is abusive, predatory behavior pure and simple.

Three other restaurants in town in which he was a partner learned of his behavior, took steps to distance him from their staffs and limit his contact with them then ultimately eliminated him as a partner by buying him out. They appear to have realized that while Sheldon may be a talented restaurateur he is nevertheless bad for business. Allowing him to open an even more alcohol related business will be bad for Sebastopol and, indeed, the reputation of the entire West County.

His behavior has been going on for a number of years. At a number of points he has made apologies and has sworn to change his ways. Apologies and promises of this sort are an integral part of the cycle of this type of violence. They often buy the perpetrator time to re-group and do it all again.

The situation now is that Lowell Sheldon has acted in such a vile manner over a period of years that his former business partners no longer want to be associated with him. They have therefore bought him out. This leaves him with a large pot of money which he wants to invest. Please...do not let him do it in Sebastopol. DENY his liquor license.

Re: City's Denial of Change of Ownership Application – Piala Georgian Cuisine

Dear Planning Commissioners,

I write to support the change of ownership application of Piala Georgian Cuisine and to, more specifically, address the City of Sebastopol's ground for denial of the application based on the involvement of Lowell Sheldon in Piala. I have known Lowell personally and professionally for seven years and, while Lowell is not without his flaws (and who is without them?), I strongly disagree with the premise that Lowell's involvement in Piala would make Piala's operation "detrimental to the health, safety, peace, morals, comfort, or general welfare of persons residing or working in the area." Independent of my opinions of Lowell and Piala, I also have significant concerns regarding the apparent process and bases on which a contrary determination was reached by the City and what that means for the basic due process rights of persons wishing to pursue business in Sebastopol, as well as the broader character of Sebastopol going forward.

In 2015, my wife Alina and I moved from San Francisco to Sebastopol. Lowell was one of the first people we met in town and is one of our best friends. Like many people probably, we met Lowell at his restaurant, Peter Lowell's. Lowell's was the place we would go, many Friday nights, and we felt welcomed into the warm familial atmosphere of the place, sitting at the bar, eating an amazing meal, while talking with Lowell and others working behind the bar and those sitting to our left or right. It was a very special place that I still miss and that I have never experienced before in any place I have lived.

Our friendship with Lowell expanded beyond the restaurant, with him inviting us to dinners and gatherings at his house, Handline when it opened, and other places. He brought us into the community and is responsible for making the connections we now have with many of our local friends. And when we had our first child exactly two weeks ago, it was Lowell who first brought us over dinner, which he then repeated a few days later.

Is Lowell a little weird? Yes. Does he rub some people the wrong way? Yes. Is he a bad person? No. He is a good person, and a close and good friend, whom I am glad will be in my son's life as he grows up in this community.

I have also known Lowell professionally, and my experience in that capacity has indicated that Lowell's empathy and concern which are demonstrated in his personal relationships are also

expressed in how he does business. I'm an attorney with experience handling commercial torts, and in the immediate aftermath of the flooding of The Barlow in 2019, Lowell reached out to me to inquire, not whether I could help just his business, The Fern Bar, but whether I could help all of the affected businesses in The Barlow. Lowell took it upon himself to organize meetings with all of the affected businesses, with the goal of sharing information and forming a unified strategy to gain compensation for the losses that all suffered. That effort resulted in my firm attaining millions of dollars in compensation for those businesses, including some of the most beloved in Sebastopol, which has allowed them to continue and prosper, and the effort catalyzed a reassessment by The Barlow of how it addresses flooding that will have a very real and substantial benefit to public safety and welfare in the future. That would very likely not have happened without Lowell.

The effort that Lowell took to make this happen is part of a consistent pattern that I have witnessed of him taking actions to assist other members of the local business community. When I reviewed the photos of the aftermath of The Barlow flooding, Lowell repeatedly appeared in cleanup photos of other people's businesses. And when The Nectary recently had its lease renewal denied by The Barlow, it was Lowell who reached out to Barney Aldridge on its behalf.

Lowell is a dedicated and significant asset to Sebastopol's business community. That is clear from the fact that he was involved in the three most important restaurants/bars to open in the last ~5 years, Handline, Fern Bar, Khom Loi, as well as Peter Lowell's, which played such an important part in so many people's quality of life in Sebastopol for so many years. And it is clear in how he conducts himself with regard to other businesses and their owners: he recognizes that in a community like Sebastopol success is not a zero-sum game; everyone's success benefits everyone.

This leads me to the process by which the City apparently made the decision to disregard all of the above and deny PIALA's application based on the unadjudicated accusations of approximately four people. The accusations of these four people should be treated with respect—and I know Lowell has done so—but they are accusations. No case has ever been brought based on those accusations and thus there has been no determination of their truth. This is important. We live, hopefully still, in a country of law and due process. And, more specifically, we live in a community that places high value on democratic principles and open-mindedness. Nobody anywhere should be denied the ability to pursue a livelihood simply on the basis that some people accuse her or him, and that the City of Sebastopol, with its proud liberal tradition, would potentially do so is very disappointing.

Finally, I want to make mention the fact that while the City's decision to deny the application is based on certain people's opinions about Lowell, PIALA is not going to run to Lowell, but by Jeff Berlin and Irma Hernandez. I've been lucky to become friends with Jeff over the last couple of years, and he is a very good and kind person, who has more love for his three sons than anyone I've ever met and is a wicked good chef and connoisseur of Georgian wine and food. Jeff successfully ran a restaurant in the East Bay for many years and is exactly the type of person that we who live in this area should want to bring his skills here and enrich our lives.

For all of the reasons above and many more that are unstated, I respectfully request that the commission reverse the denial of Piala's application and let the community enjoy what Piala will bring to it.

On several occasions, I was invited to socialize with Lowell, Natalie and their staff, after hours. It appeared to me that the group had a lot in common, really enjoyed each other's company and had a shared sense of purpose in providing Sebastopol with deliciously prepared local food in a relaxed, convivial atmosphere. Lowell's restaurants, in my opinion, seemed like an awesome place to work.

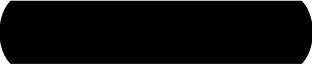

My observations of Lowell's business operations were sometimes as a customer but most often I would see the "back of the house." I would either come in and conduct a wine tasting for Lowell or deliver wine, lamb or vegetables into the kitchen. I never observed anything unprofessional take place. By all accounts it seemed like a positive work environment, especially considering that many restaurants are operated in an unprofessional manner. This never seemed to be the case at Peter Lowell's or Handline.

In my estimation, Lowell's restaurants have always had a positive impact on the town of Sebastopol and the broader community of food and wine. A strong argument exists that Lowell's endeavors have made the Sebastopol food scene what it is today and helped other businesses as the waters rise. I do not believe that Lowell should be blocked from opening a restaurant that serves beer and wine. I do not believe that this is appropriate. Furthermore I believe that Piala would be a wonderful addition to the Sebastopol restaurant scene.

Lowell has elevated the restaurant scene in Sebastopol and he ought to be allowed to continue doing this. Lowell is very talented and it would be a mistake to drive his talent out of Sebastopol. Please feel free to contact me with any questions about any of my statements.



I am writing because I understand Lowell Sheldon is running into difficulties with the City in having a new venture approved.



Lowell is also a fallible person—as well all are. Full of the idiosyncrasies that make up any personality—and thank god for that. I shudder to think of living in a world where none of us makes mistakes, none of us has a chance to right our wrongs, where only some people live in glass houses. I'm aware of the allegations regarding his misconduct. I have read the newspaper articles and take what's been reported seriously. There's no excuse for the pain he has caused others to feel. But I believe his strengths as a person outweigh his weaknesses by a landslide, and that the personal work he's done in the last several years to correct his behavior bears this out. He's listened and acted, and made lasting changes. For the City of Sebastopol to block the change of ownership request for Píala Georgina Cuisine leaves no room for that growth and change to be seen and felt in the community.

I urge you to take a step forward with him by approving the change of ownership application for Píala Georgian Cuisine.

I was the owner and proprietor of 1stWave Interactive, a web design and UX consultancy, located in the same building and directly adjacent to the Peter Lowell's Restaurant for the period of September 2008 to April 2022. I was a witness to the comings and goings of restaurant patrons, employees and management for the entirety of the restaurants 10+ years of existence. At no time did I witness unwanted sexual jokes or inappropriate behavior on the part of management or employees. Specifically, I did not witness any behavior on the part of Lowell Sheldon that was sexually inappropriate with employees.

What I witnessed was a restaurant culture of employees and management fraternizing in the mode of a "collective" friendship driven business. Chefs, wait staff, and managers would hang-out together for long hours after closing time, eating food and drinking wine together. From the outside, the appearance was that of a group of young people having fun and enjoying themselves.

I read the news articles of the accusations of inappropriate behavior on the part of Lowell Sheldon and his management style. Though I did not witness this behavior during the hundreds of hours directly observing and engaging with the restaurant, I do not dispute any of the women who stepped forward with their own personal accounts. My own personal observation and what I overheard from time to time from others, was that Lowell Sheldon could be "moody" and "aloof" on occasion — very friendly one day and curt and distracted the next day. Peter Lowell's was a beloved restaurant and local favorite widely known for spearheading the use of local organic food and establishing strong relationships with local farmers.

Pila Restaurant should be allowed to do business in Sebastopol. Lowell Sheldon, despite personal faults, has been a visionary creator of unique restaurant experiences in Sebastopol and has brought much value to the town and it's culture with his focus on Organic farm to table cuisine. Patrons and residents of Sonoma County should have the freedom to support or not support Pila restaurant based on the way the business conducts itself and treats employees.

Dear Sebastopol City Council Members, I am writing to strongly support the change of ownership application from Peking Chef at 7233 Healdsburg Ave to Píala Georgian Cuisine, which was submitted by Jeff Berlin, Irma Hernandez and Lowell Sheldon.

As a friend of Lowell Sheldon's parents, I was among the first to dine at Peter Lowell's Café in 2007. And it is not an exaggeration to say that I (and my little family) dined at Lowell's numerous times a month from 2007 to 2013, until we moved from Sebastopol to San Francisco. The reason we dined regularly at Lowell's for six years is because the food was terrific, the environment was friendly and community-minded (attributes that cannot be faked in small open floor-plans), and the ethos was creative, sustainable (supported humane meat and farm to table experience), and progressive (staff received benefits and a living wage).

Furthermore, my daughter, Amelia began raising chickens when she was five years old. Three years later, Amelia had grown her flock to 30 chickens and wanted to sell the eggs. Acquainted with Lowell from eating regularly at his restaurant, eight-year-old Amelia (with knees knocking) asked Lowell if he would buy eggs from her. Lowell respectfully asked Amelia the same questions he'd ask any food vendor and then agreed to purchase her eggs. I am a feminist and victim's rights advocate, and greatly distressed that a handful of former employees (out of the hundreds that worked at Lowell's Café) have been allowed to receive their 15-minutes of fame by slandering Lowell Sheldon. If it weren't for their attacks on Lowell, none of the supposed victims would have any agency or celebrity. Please do not allow a few disgruntled employees using McCarthyism style bullying to continue to make news by ruining the career of a much beloved local business leader. Worst of all, when people make false accusations (and in this case, mountains out of mole hills) this leads to the disbelief of people who have faced real workplace harassment or abuse.

Dear City of Sebastopol Commissioners,

I write to urge you to reconsider your decision to deny the transfer application of Píala Georgian Cuisine and to express my unequivocal support for the addition of this restaurant to the Sebastopol community. The denial of a beer and wine license transfer to a prospective establishment like Píala is effectively a ban of the business entirely, a measure that you as elected officials should exercise in only the most clear cut situations. I hope that you will give this and other letters in support of Píala equal weight to those previously offered in protest to this application and grant Píala's transfer application.

As a feminist and someone who has known Lowell for over a decade, I am dismayed by the rush to characterize him in such damning and sexist absolutes without any attempt to hear from him, paint a complete picture, or accord even a modicum of due process. The Lowell I know -- both as a frequent diner in his restaurants and through our shared community -- does not at all square with the image presented by a handful of vocal former employees in recent months. Lowell is a creative, hard working, principled, and thoroughly kind and generous person. As is often the case with young entrepreneurs, Lowell's talent and vision outpaced his professionalism, and at times he blurred personal and professional boundaries. But he isn't a menace. His restaurants were built around a core commitment to community -- with an emphasis on sourcing from local farms, paying a living wage and providing healthcare, and contributing to the professional growth of others in the community -- and I personally felt this shared sense of community among his teams. I have known several people who've worked in Lowell's restaurants over the years -- and spent countless nights with them during and after hours -- and what they expressed and what I experienced first hand was unequivocally positive, supportive, and safe.

If you are going to consider anything about Lowell's character in determining the outcome of Píala's application, you need to consider all of who he is, including what I think stands out most about him: his willingness to hear and engage with clear and direct criticism (even when it's *hard*), to introspect on it, and to become better. I am not sure I know anyone who would have taken the sort of character assaults Lowell experienced this past year and responded in the manner that Lowell did, with a sincere openness and a deep desire to improve himself and repair any wrongs felt by the community. Lowell and I have talked extensively over the past several months about the allegations that have surfaced -- and rather than dwelling on the falsity and exaggerated nature of many of them, his primary focus has been on how he can learn, grow, and mend. This is a quality we should look for in all business owners and employers.

It is in this spirit that Lowell has approached the Píala project he's partnered with Jeff and Irma on, putting in place all the necessary guardrails to ensure others in the community will feel comfortable with his involvement in a new restaurant, regardless of whether he actually poses any risk. The Píala partnership expressly provides that Lowell *will have no involvement in the* operational management or staffing of the

restaurant in any capacity, and that partners, restaurant veterans Jeff and Irma, will oversee all operations, staffing, and management. I know Jeff and Irma personally to be respectful, professional, and kind. I understand they have also undergone harassment training and that Piala has taken the additional measure of having a specialized HR firm handle those matters for the business.

Given all of the above, there is no legitimate basis for you to deny Piala's transfer application and effectively bar Piala from opening its doors to the Sebastopol community. Please reconsider your decision and grant Piala the transfer application it is seeking.

While the allegations against Lowell are very troubling, they have not been proven in a court of law and yet Lowell has undertaken significant work to address what he admits was inappropriate behavior. He has undergone three years of therapy, six months of weekly work with an organization specializing in restorative justice to better understand his impact on others, three two-hour trainings on consent and power dynamics, and two other trainings specifically to better understand and address sexual harassment in the workplace. He did this voluntarily.

This is a good outcome of a bad situation. What would denying the business transfer accomplish? Lowell should not be barred from earning a living in Sebastopol. He deserves the chance to prove himself. Those that find him objectionable need not work at Piala or dine there.

The planning commission's denial raises a number of questions:

- Will the commission review all transfers granted to ensure the parties are held to the same standard it is seeking to hold Lowell? What is that standard?
- If similar allegations are made about other business owners, will their business standing be revoked? If not, why not?
- Is the commission establishing a new policy that those who have been accused of appropriate behavior may not own businesses in Sebastopol? What is the legal basis of this?

I am writing in support of the change of ownership application for Piala Georgian cuisine and owner Lowell Sheldon. There are two points of emphasis that I would like to convey in this letter. First, I feel very strongly that the city Planning Director Kari Svanstrom's decision to deny the application based on a letter from former employees of Lowell is short sighted and unprofessional. While she cited a weak secondary claim of the establishment not being a restaurant (a claim easily shown to be untrue), Ms. Svanstrom was quoted in a recent Press Democrat article as saying she "basically denied it on the content of the letter." To think that a city official would use her position to punish a business owner and its potential employees based on a letter signed by 18 people is maddening. To simply accept that account as fact absent any criminal charges, or even a civil proceeding, and without asking for input from any other former employees, shows a striking willingness to bow to a small special interest group in setting city policy. That is a dangerous slope to go down in terms of how the city interacts with potential new businesses and proprietors. Is the city going to investigate and judge every new business owner's past before they are allowed to set up shop? That strikes me as decidedly outside of the duty of our city employees, and presents an inhospitable regulatory environment for prospective businesses.

My second point of emphasis in writing this letter is to provide a contrasting view of the character of Lowell Sheldon. I have known Lowell for about 20 years. I saw him grow from a young, inexperienced restaurateur, into a leader of the local food movement that honors the valuable work of our local farmers and ranchers. His restaurants also led the push to give workers a living wage, and operated with a heightened commitment to community building and support. Not just as a patron, but as a friend, I have interacted with him in many ways over the years. Our children went to pre-school together and continue to be close friends, and I have come to know a man who is a wonderful father and generous, caring friend.

I don't claim that Lowell is a man without flaws. The birth of his first restaurant came during his 20's, and he has admitted to being unprepared for the role of owner/manager at such an age. I implore this commission to do the right thing and allow him the chance to prove that we are a community of growth and change.

Me and my team of other employees both male and female looked forward to going to work and had a great camaraderie. Things were run smoothly and professionally, and any reports of partying in the workplace or underage drinking etc. were not something I witnessed, and would have been isolated incidents not the norm. The newspapers never came to interview me or many of my coworkers for an alternate perspective, and I think the narrative is warped and inaccurate.

Dear Planning Commission of Sebastopol California,

My name is Timothy Ryan and I'm writing to voice my gravest concerns as a West Sonoma County community member and ex-employee of one of Lowell Sheldon's businesses.

First and foremost I'd like to state that when I met Lowell Sheldon at Handline back in 2016 my first impression was that he was intelligent, charming and talented with his restaurant concepts. I liked him. We got along in many ways. I was grateful to gain employment at the new much-talked-about restaurant in Sebastopol, Handline. Handline had an ethos with regard to the local food products they sourced and their beverage program which was inline with mine. I did not work with Lowell directly very often because his role was not related to daily operations. He was often in the establishment making additions to infrastructure, repairs, landscaping, or hanging out with friends. He would always make it clear that he owned the place by acting as the general manager or proprietor. He would often be engaged in hyper-vigilant behavior which made many employees irritated. After he hired me we got along rather well in the beginning.

The talk among the town was that he was talented at what he did. Yet there was always a qualifier after this statement. People would tell me that he is socially awkward and has a serious issue with boundaries. After which they would dismiss it as "it's just Lowell's spectrum-like awkward behavior." On many occasions some people warned me that he was "a creep" and to stay away. Other people seemed to overlook these notions which they had about Lowell because he's a local figure in a position of power who had multiple popular restaurants/bars (his dad built much of this community—as most of the locals know)

I often frequented the establishment which he managed down the road named after himself—Lowell's. For years I'd eat and work on my laptop there for lunch, multiple times a week. I enjoyed the good food and company of the employees, many of whom I had a casual friendship with. During the years of working with Lowell and patronizing his eponymous restaurant, I got to know and observe him in the work environment. He liked to push boundaries and test his dominance over employees in multiple ways. Whether verbally or physically, it always made me feel uncomfortable to witness. I could see the discomfort within the employees and they'd often tell me how difficult it was to work with him. While this did not include all of the employees, it included many. He had a way with building people up, charming them and then tearing them down.

I'd see him out at the local bars after work with employees and other industry folks. The lack of respect for boundaries was apparent in this setting as well. He often asked folks to sit on his lap.

I had some very uncomfortable encounters with him myself between working at Handline and frequenting Lowell's. On several occasions he grabbed my hips and pressed his pelvis into me from behind while at work. He stuck his tongue in my ear while working. He grabbed my ass. It was a game of power and "fun" for him I suppose. My way to combat it was to fight fire with fire and act like I was beyond it all. I'd had more experience in the industry than he did and came from SF, which afforded me some respect and more leeway with him. I noticed a darkness in him beyond the charm. I'd nervously laugh off many of his indiscretions as did many others. He would regularly massage employees and patrons at his establishments without solicitation. A few of his friends were fine with it but most were not. I know someone who actually included these unsolicited massage encounters into his stand-up routine at Hopmonk's open mic. He said it was

an awkward and provocative bit but that it got nervous laughs because people all knew Lowell's regular disregard for boundaries. Many folks won't say this on the record about him because they don't want to disrupt the status quo or get mixed up in "these kinds of affairs." The fact that people (myself included) could dismiss this behavior and then offer him more power in the form of a new bar frightens me. We've all read the SF Chronicle, Press Democrat and Bohemien articles investigating the horrific accusations of sexual assault and misconduct within our community against Mr. Sheldon. When I distill my direct experiences of Lowell with the experiences others have relayed to me in confidence, I am left with one unequivocal calling: SPEAK UP!

Previously I've dismissed this behavior out of fear of standing up to a local figure in power. Someone who had access to all the top wine producers, venues, restaurants, other powerful and charming figures. I didn't want to disturb my reputation in the community. I shouldn't have dismissed this. I regret this with heartbreaking remorse. I knew that he was playing these power dynamics with his employees and others. I may have been able to prevent the abuse of strangers and people I care about had I spoken truth to power. Demanded accountability. That is why I'm writing this letter to you now. If Lowell Sheldon gets to own another bar in this county it would be shameful, disgraceful and dangerous.

I grew up working in restaurants nearly my whole life in San Francisco. This type of predatory behavior is par for the course. Sadly, it's expected. To avoid embarrassment and/or losing your job, you laugh it off or just grit your teeth and let it happen, repeatedly. This behavior is so rampant and normalized in the service industry (and many others) that people in a position of power have carte blanche to do what they please without accountability. I used to see Lowell nearly bring employees to tears just for the sake of toying with them, over a napkin on the ground. Because he could. I sincerely pray that you take all of this into consideration.

We have an opportunity to do the right thing here for our community by pleading to the Planning Commission of Sebastopol to **NOT GRANT** Lowell Sheldon access to a permit for PIALA wine bar, or any other future establishments. This is my plea. For the safety of our community please do the right thing.

We live at and own a commercial property just around the corner from the Freestone Hotel that Lowell Sheldon owns and wants to turn into a tavern and hotel. We are naturally in support of appropriate and respectful commercial development/uses of properties in Freestone, but it is impossible to support this proposed use, for so many reasons.

We moved here because of the quiet serenity and warmth of this community, and intend for this to be our permanent home. We have a young daughter whose only place to ride her tricycle or explore in her stroller is down Freestone St... the hotel occupying that entire street destroys what little shared community/pedestrian-friendly space that we have. The proposed plan would also create noise, disturbances, and other hazards that are likely to occur in places where heavy drinking late into the night is promoted.

The proposed water usage, noise, parking issues, and traffic would dramatically impact us and turn our beautiful historic town into something it was not intended to be and dramatically change its character. I have personal experience with Lowell Sheldon which I believe to be relevant. He took large sums of money from my mother, calling the more than \$100,000 over about 2 years a "line of credit" for the restaurant which she paid in advance with no written agreement. I don't know how long this had been going on before I was alerted by her financial advisor in 2015.

My mother moved to Sebastopol in 2008, after the recent loss of both her son and husband to cancer. She was at the time 74-81 years old. She developed a serious drinking problem for the first time in her life.

When I became aware of this situation, I met with Sheldon to ask him to provide me with paperwork for their arrangement. I was met by a cold and dismissive response and was told that he would not be providing any receipts or paperwork as I requested. I also told him how concerned I was about my mother's drinking and asked if he would please ask his staff to not offer or encourage the alcohol. I told him I did not expect anyone to police her drinking but any help with this matter would be appreciated. Again, he was very dismissive and uncaring. I left that meeting feeling sad and frustrated. It was very clear to me that there was no emotional connection to her in any way, yet he seemed to have a clear conscience about taking money from her and seemed inconvenienced to talk to me.


I was unable to put a stop to this situation until I threatened him with an elder abuse charge and took my mother from the condo where she was living and moved her to a retirement community in 2017. At the end of her time at the complex located behind Sheldon's restaurant, he was having open wine delivered to her door at 8:00 in the morning. Although I never pressed charges and he remained in business, the thoughtless and reckless nature of his behavior was the source of much pain for myself and my family. I have heard of his sexual harrassment and drug abuse and because of my experience with him, believe the accusations stated by his victims. His toxic behavior makes me believe that the city of Sebastopol would be avoiding future ethical and legal problems by standing behind those who have been traumatized by Lowell Sheldon.

I am a 44 year resident of Sebastopol with a daughter who was one of his victims. I strongly support the denial of the use permit for Lowell Shelton's new restaurant on 3 levels.

Firstly, as former General Manager of the Culinary Institute of America in Saint Helena and also for former Food and Beverage Director and Executive Chef of the Sheraton Hotel in Petaluma, I can unequivocally state that Lowell Sheldon's behavior would not be tolerated in the corporate restaurant world. After the 1st allegation he would have been suspended and after the 2nd, he would have been dismissed. If he had been allowed to remain at his job, we would have been open to many lawsuits. Because Lowell's businesses were privately owned, the young ladies had no place to voice their complaints or get recourse. This would be the case if Lowell opened another restaurant.

Secondly, Mr. Sheldon has not really publicly acknowledged his sexual harassment of these women. He has used the terms "I ran the restaurant in a sloppy manner", "behaving inappropriately", "mistake", etc. I believe he does not really think he has done anything wrong. As a community elder, we are expected to keep our town safe. Three major restaurant owners have extricated him. We cannot let this predator back in our midst.

Thirdly and most importantly. my daughter was one of his victims. My daughter was born and raised here. She was recruited by Lowell Sheldon to be director of communications and marketing for his restaurant group Lowell's, Handline and Fern Bar. Dear Planning Director and Commission of Sebastopol,

My name is Alexandra Lopez, and I am a former employee of Lowell Sheldon's. I am writing to urge the Commission to reject Sheldon's appeal to pursue an alcohol license. The original decision to deny Sheldon's Alcohol Transfer and Alcohol Use Permit application was based on well documented and credible evidence, and the commission recognized that Sheldon's involvement creates the potential to be detrimental to the health, safety, morals, and general welfare of the community, including potential employees, customers, and other members of the general public, and not be in the best interest of the City.

As someone who has both witnessed and personally experienced Sheldon's abuse and toxic behavior, I can unequivocally say that he has not learned from nor properly addressed his actions and therefore remains a threat to community well-being. There have been several occasions over the past few years where I have had to ask that Sheldon not contact me directly in any form, and yet he continues to demonstrate that my boundary is not important by sending me emails or allowing his family members to contact me. The most recent incident occurred on June 9th, 2022. In his correspondence he reminds me that we share a community and he thinks of me and my family when he passes my house. This is very threatening and manipulative language from someone who claims to have an understanding of the harms he has caused. He goes on in the email to bully us into ceasing our activism and attempting to gaslight us by saying that our work is "counterproductive" and how many are against our cause. Let me start by defining what this entire situation is about, because supporters of Lowell Sheldon seem to be confused -- no one is attempting to bar Lowell from the community. No one is saying that he cannot own a restaurant, no one is saying that he cannot make money or collect an income. Why these other things keep being brought up by supporters of Lowell is beyond confusing to me and seems to be an attempt at mudding the waters and taking attention away from the intent of what's actually happening. We do not think that any business that has anything to do with Lowell should be allowed a liquor license or a legal basis on which they may serve alcohol given the ample examples of Lowell abusing his power and engaging in inappropriate behavior with his own employees and other community members when intoxicated and after offering and serving others alcohol in his establishments, **often after hours** (not during active operation).

My personal experiences with Lowell are few enough to be listed here, I will admit. In the last five years he very seldomly came into the coffee shop that I manage, though it seems that each visit carried something else vaguely problematic. He's never treated any of our team members like they were anything other than a means to get him his order, and never like they were actual living and breathing human beings attempting to form a customer service connection with him, as that's important to us here. He'd usually give a fake name for whatever reason, and the most common fake name he'd use is a Latino name that is not anything close to his actual name. Because he gave the name of a Latino man that is not him, he would typically not pick up his order when the name was called out. Once he came in while I was covering a break on the register -- he spoke on the phone throughout the entire transaction and once we reached the end of the transaction and had already begun preparing his order, he told me that he did not have his wallet on him but asked if it was, "cool," because he, "knows the owners." Not only is it not uncommon for folks in our community to know our owners because they are big on community outreach and make an effort to support other local businesses, but they are by no means friends or even really acquaintances as we've known about the problematic culture surrounding Lowell since long before any of the articles about him came out and they didn't have much engagement with him even before that. There was no offer to come back and pay at a later date, no apology, and to think that he didn't have Apple Pay on his phone in 2021 is absurd. Another time I was eating dinner with my partner at Handline and Lowell and his ex-wife spent 20 minutes out on the dining patio yelling at each other in front of us and other diners before leaving one of their large tables completely filled with half-eaten dishes. Five minutes later, a Handline employee came out asking what had happened and said that no one had paid an over \$300 bill for their meal. My last one-on-one interaction with Lowell was when I told him that he was no longer welcome to come into the establishment that I manage to ensure the safety and comfort of our team members and guests, as we have both team members and regular customers who have been abused by Lowell in the past. He didn't look at me the entire time we spoke, then asked if I was, "for real," before leaving.

To the folks who say he's a great guy because he came by your table when you were a regular at Lowell's: that is how owners of businesses typically operate. He wanted your money, and he showed you the face he wanted you to see when you were paying the elevated prices at his restaurant. To discredit folks who worked with him and knew him on a personal level because you had a shallow experience with him as his customer is hardly a credit to his character.

To the folks who say he's done great things for the county and the country when it comes to food and sustainability: sure. Other people are capable of picking up that torch but also Lowell positively contributing to the food industry does not require him to own a business that has a liquor license.

To the folks that say that Lowell will not have any managerial power or will not be operating any of these businesses: we have documented accounts from the people that he abused that many of the instances of abuse happened **after hours**. This means that Lowell didn't need to be on shift all day, he does not need to be involved with business operations to show up after close and offer people alcohol. Furthermore, the obsession with obtaining a liquor license and the implication that serving alcohol is a necessity to his businesses after so many of the recorded instances of abuse happened after Lowell offered people alcohol, as their supervisor and owner of the business they were employed at, should raise more suspicion than it is.

To the folks who say that they will not speak out against Lowell in fear of online retaliation from the folks that Lowell has abused or their supporters: the only instances of online retaliation have come from Lowell's own family members, like his mother and his brother who have both harassed people that I know personally, be it publicly over social media or privately via email. Lowell's family members have slandered the community members that Lowell has abused, saying they just want fifteen minutes of fame or that they're just looking for money despite not seeking any monetary compensation for what has happened to them.

I have not been personally abused by Lowell Sheldon other than being mistreated as a customer service worker by him, though in my opinion the way that folks treat customer service workers says a lot about them. Regardless, I am a woman in our community that has been sexually abused, and a woman in the world that has been sexually abused by an employer in the restaurant industry. We know that this is not uncommon, or rather that it is extremely common and is something that is almost expected if you're entering the restaurant industry. I do not accept this, and I think that we need to do everything in our power to change this. In many instances this abuse does not involve alcohol or drug abuse, but we have multiple personal accounts that claim that this is a huge factor in nearly every instance of abuse involving Lowell. This is why this discussion is being had, this is why his businesses should not be allowed to serve alcohol. I care about other people in this community, I have managed so many who have gone on to enter the restaurant industry and things like this make me feel concerned for their safety. This community loves to virtue signal at any opportunity, except for when it comes to holding their own community members accountable. We'll show out for protests, hang flags and post signs in our yards for causes that do not actually directly affect our community, but when someone who was known as a pillar of food and farm culture in our county shows that he doesn't deserve the trust y'all put in him you don't want to take a hard look at that. If we're going to pretend that we care about abuse happening to people we don't know in other places, it's time to start actually showing that we care about the abuse that is happening to our own community members, right here at home.

My name is Freddie Francis. I've lived in West County for seven years. Several survivors of Lowell Sheldon's sexual assault, harassment, and workplace abuse are close friends of mine. I have been supporting them as they bravely have spoken out in support of creating a safer and healthier Sebastopol for all.

Anyone reading this knows about the multiple women and workers in our community who spoke out about their experiences of sexual assault, harassment, and workplace abuse at the hands of Lowell Sheldon. If you are reviewing these public comments, you have likely read additional accounts of harassment and manipulation, including from my friend Lisa Kurtz, who shared her story of how Lowell Sheldon extracted \$100,000 from her elderly mother without a written agreement, and with the use of alcohol as a tool of manipulation.

If you are reviewing these public comments, you are also hearing from Sheldon's supporters, who in addition to victimblaming accusations of "seeking celebrity" and glossing over his 10+ year history of this behavior, make calls for forgiveness and redemption. I am all for forgiveness and redemption, and I strongly believe in the power of people who have committed violence to transform and heal. However, from what I have witnessed firsthand since September 2021 when articles in the SF Chronicle, Press Democrat, and Bohemian came out, it is clear to me that Sheldon is far from reformed.

- Lowell Sheldon has repeatedly breached consent by ignoring survivors' requests for no-contact, including reaching out to victims' family members, spouses, and friends in person, over email, and on social media.
- Summerfield Waldorf School requested that Sheldon wait in his car and have staff walk his children to his car for pickup. He at first agreed to these terms then stopped doing this after about 2 weeks, in spite of the fact that someone he sexually assaulted is also a parent at Summerfield.
- Sheldon abandoned a transformative justice process with Ahimsa Collective, and violated their written agreement to keep the process private by touting it as an indication of his reform while soliciting public comments.
- Multiple of Sheldon's friends and family members have harassed the survivors, their family members, and supporters in person and online. Though Ahimsa Collective requested that Sheldon ask his family members to stop, the harassment has continued in the leadup to this hearing.
- On May 23rd, Sheldon sent out a letter intended to be seen only by his supporters that denied the breadth of his actions and urged them to submit public comments anonymously and directly to him "out of fear of retaliation [from survivors]," in spite of his ongoing harassment and retaliation of survivors and their supporters.

- On June 9th, Sheldon sent a PDF of his supporters' letters to the survivors as a means of intimidation and urged them to quit their advocacy, writing "your work to keep me from moving forward with my professional life is counterproductive. It turns many people in this community against your cause."
- Sheldon has issued a number of contradictory statements, denying sexual harassment (with the exception of the single comment telling his employee to "come sit on daddy's lap") yet not denying the graphic and violent sexual assault reported in the Bohemian. In these letters he also made ridiculous claims about "no complaints ever being brought forth" during his management of Lowell's in spite of heavily documented evidence to the contrary. He continues to emphasize how he will not be a part of Piala operations, in spite of the fact that many of his abuses and transgressions occurred out of the workplace, and when he was already banned from entering his former businesses.

Expressing the sentiment of remorse and taking accountability are different things. It's great that Sheldon feels remorseful; that's completely appropriate. But the work of taking responsibility, personal transformation, and integrating these lessons into his personal and professional life takes time, and Sheldon hasn't for a second taken a pause in his entrepreneurial pursuits.

I am asking the Sebastopol Planning Commission to use their discretion in upholding the denial of an alcohol license for Lowell Sheldon and Piala LLC, out of concern for the safety of women, workers, and community members in Sebastopol and beyond.

I have known her since childhood and know her to be an honest person. The young women, who were sexually harassed and assaulted by Mr. Sheldon, are very courageous to stand up to this predator who abused his power as their boss. His behavior was unacceptable. In fact, even his former partners in three of his former restaurants have all severed ties with him because of his inappropriate behavior.

I have concern for any young women who work for him; especially because he is still not willing to understand or acknowledge the trauma he caused. He states that he has changed, but he still thinks the "inappropriate behavior" of which he has been accused is just the "mixing of my personal life with my business" as he stated to the Press Democrat in its May 27th issue.
