#### **INTRODUCTION/PURPOSE:**

The item is to request Council consider and approve the purchase of a Fire Rescue truck.

#### BACKGROUND:

The fire department has a 1994 rescue truck ("rescue") used for responses to medical emergencies, auto extrication, and other rescue incidents. A replacement vehicle has become a critical need for the city as the current rescue truck was involved in a traffic collision resulting in significant damage and rendering the vehicle inoperable without significant repairs.

Originally scheduled for replacement in 2017 at an estimated \$350,000, the rescue has outlasted its life expectancy and was scheduled to be replaced in an upcoming budget cycle. The City has been presented with an opportunity to purchase a 2020 F550 rescue truck from the Hopland Fire Department. The Hopland Fire Department just recently replaced their Ford F550 rescue truck and has declared their vehicle surplus. They are making that vehicle available to the City of Sebastopol for the purchase price of \$80,000.00. In light of a recent accident where the City of Sebastopol Fire Rescue was involved in a traffic collision resulting in significant damage and rendering the vehicle inoperable without significant repairs, the potential purchase of this vehicle comes at an opportune time.

The Fire ad Hoc Committee received the intent to purchase letter after requesting it on October 20, 2023, and reviewed the request as a committee on November 30, 2023.

#### **DISCUSSION:**

The proposed vehicle is a 2020 Ford F550 diesel-powered four door cab and chassis and has a rescue truck compartment box. The configuration of the equipment box is such that all equipment currently on the 1994 rescue will transfer to this vehicle. The 4-door cab provides safe seating for up to 5 firefighters. The vehicle will come with radios, and an emergency light system. The vehicle is powered by a diesel engine that meets all current requirements specific to emission standards and provides sufficient power to handle the payload of the vehicle. The unit also comes with a small water tank and pump sufficient to handle small fires along the bike trails and off-road fire events.

Agenda Item #11 The proposed vehicle is a significant value. As is the case with buying a used vehicle, the City will avoid the initial depreciation. The vehicle comes with other savings in the form of the radio, siren, emergency lighting package already installed and consistent to our standards. To purchase a new version of the proposed vehicle would cost at least \$200,000.00. The build time of new fire vehicles is also extended resulting in a minimum 1-year build and delivery time for this type of vehicle.

This vehicle meets the needs of the department providing a vehicle designed and equipped to respond with specialized rescue equipment and basic emergency medical responses. Additionally, this vehicle does not require a special driver's license to operate as required for the 1994 rescue and other fire vehicles. It has become critical to have this type of vehicle as a part of the fire department inventory to prevent situations where volunteers have responded to the station but cannot initiate a response to an emergency as they are not licensed or qualified yet to drive the other fire engines.

The potential funding sources that can be applied to make the purchase of the vehicle as recommended are as follows:

- FY 23-24 adopted budget has \$40,000 as a placeholder for a rescue replacement in account 124-3102-5100.
- The city will be receiving unanticipated \$24,691.00 revenue for the use of the department's Type-3 fire engine on a state fire earlier this year. Those funds will go into the vehicle replacement fund; they can be considered an offset in funding the purchase of the vehicle. However, in the meantime, the City can utilize the vehicle replacement reserve fund to pay for the balance of this fire rescue truck which required an increase in budget of \$40,000.
- As noted above, the City's fire rescue truck was involved in an accident. As a result of this wreck, the city should receive some funding through the insurance claim process. This funding can also be considered an offset and can reimburse the vehicle replacement fund. Per our insurance carrier, the claim is still being reviewed; the policy is for the replacement value of the damaged vehicle. The value of the damaged vehicle is approximately \$150,000 to \$250,000 depending on how insurance views the replacement strategy (i.e. just the cab and chassis vs an entire new rescue truck). There will also be a deductible that the city will be responsible for.

#### **RECOMMENDATION:**

Staff recommends Council consider and approve \$80,000.00 for the purchase of 2020 F550 Fire rescue truck.

# A RESOLUTION OF THE SEBASTOPOL CITY COUNCIL APPROVING ADJUSTMENTS TO THE BUDGET OF FISCAL YEAR 2023-24 FOR A PURCHASE OF 2020 F550 FIRE RESCUE VEHICLE

WHEREAS, the City of Sebastopol City Council did, on June 27, 2023, adopt the budget for fiscal year 2023-24; and

WHEREAS, the City of Sebastopol Fire Rescue was involved in a traffic collision resulting in significant damage and rendering the vehicle inoperable without significant repairs; and

WHEREAS, the City has been presented with an opportunity to purchase a 2020 F550 rescue truck from the Hopland Fire Department. The Hopland Fire Department just recently replaced their Ford F550 rescue truck and has declared their vehicle surplus. They are making that vehicle available to the City of Sebastopol for the purchase price of \$80,000; and

WHEREAS, FY 23-24 adopted budget has a \$40,000 as a placeholder for a rescue replacement in account 124-3102-5100; and

The value of the damaged vehicle is approximately \$150,000 to \$250,000 depending on how insurance views the replacement strategy (i.e. just the cab and chassis vs an entire new rescue truck).

**NOW, THEREFORE, BE IT RESOLVED,** that the City Council of the City of Sebastopol does authorize and approve a budget amendment to the vehicle replacement reserve fund account 104-31-02-5100 in the amount of \$40,000 for a purchase a 2020 F550 rescue truck from the Hopland Fire Department, and until such time the reimbursement of Type-3 engine from the state and from the insurance partner for the replacement value of the damage vehicle to be deposited back into vehicle replacement reserve fund.
