#### INTRODUCTION/PURPOSE

This item is for City Council consideration of Award of Construction Contract to Pat Nelson Construction Inc. for AmeriCorps Trail Extension ("Project"), Contract No. 2022-03, authorization to City Manager to execute the contract and to approve contract change orders up to 10% of the contract award amount, and adoption of Resolution approving a budget amendment to the Fiscal Year 2022-23 CIP Budget for CIP Project #0411-73.00.

#### **BACKGROUND**

The Project, AmeriCorps Trail Extension, is Capital Improvement Program (CIP) Project #0411-73.00 in the adopted Fiscal Year 2022-23 CIP Budget. The Project proposes to construct a trail extension, a pedestrian bridge at Zimpher Creek and make improvements to existing path segments. See Attachment 1 for the location map.

The Project is located east of Morris Street and on the west side of the Laguna Preserve, extending north to south for about 1,850 feet over City property in the area between Laguna Park and Sebastopol Avenue near the west end of the Hwy. 12 bridge. The Project will improve a dirt path in this area, which has been seasonally used since the early 1990's, with minor grading to cut high points and fill low areas along the alignment to provide a consistent six-ft wide clear trail. On the improved graded trail will be placed a 4-inch-thick section of compacted imported rock aggregate to form a stable walking surface. The improved trail will continue south, extending over low-lying areas that are prone to ponding, by constructing a 6-ft wide "puncheon" bridge. This is a low wood structure set on a series of concrete pier blocks to elevate the trail above typical ponding levels for near year-round use, while minimizing the grading work in this area. Where Zimpher Creek crosses the trail, a new lightweight aluminum pedestrian bridge that will be bolted together in the field will be installed on new concrete footings. From this point the trail extension will continue south, gently winding through a grass plain area, and finally connecting to the existing concrete sidewalk on the north side of Hwy. 12.

In the Project proposal section of the bid documents the bid was set up to include the "Base Bid Schedule" (Base Bid), which includes all the basic elements for making the trail improvements and crossing the low ponding area and Zimpher Creek. These elements address standard project concerns such as mobilization and regulatory issues (e.g., stormwater protection and erosion/sediment control), site clearing and grading, trail surfacing, crossing structures, drainage, etc. In addition to the basic improvement elements, an additive alternate bid schedule was

included to provide for trail enhancements for possible consideration, pending available funding resulting from favorable base bidding. These trail enhancements alternates include weed barrier to minimize weed intrusion through the trail, metal edging for preserving the trail edge integrity over future years of use and wear, and a finer, tighter surfacing (i.e., decomposed granite) for an even more consistent, uniform walking surface. The basis for determining the lowest bid as specified in the bid documents is the lowest bid price on the Base Bid without consideration of the prices on alternate bid items.

The Project is estimated to start in late June 2023, with duration of approximately four (4) months, and completion in Fall 2023.

#### DISCUSSION

At its regular meeting on April 4, 2023, the City Council approved the Plans and Specifications and authorized to bid the Project. A notice inviting bids was issued in accordance with the Public Contract Code. The City received three (3) bids and the lowest apparent and responsive Base Bid was from Pat Nelson Construction Inc. in the amount of \$325,200. The other bids received were from the apparent second low base bid of \$405,810 and the high base bid of \$561,892.67. There were no bid irregularities. A summary of all bids received can be found in Attachment 2.

The lowest Base Bid for specified bid items is the product of estimated quantities and fixed unit prices for the total recommended construction contract amount of \$325,200. The Alternate Bid sum submitted by Pat Nelson Construction, Inc. for trail enhancements is \$212,670, and would result in exceeding the available budget, and the therefore is not being recommended for consideration. A contingency of up to ten percent (10%) of the Base Bid contract amount, or \$32,520, is recommended for covering unforeseen conditions that may arise during the work.

Staff is recommending that additional funding be provided to accommodate a 10% contingency for potential contract change orders, and an allowance of up to 15% for construction management and inspection (CM) as summarized in Table 1 below.

# **GOALS:**

#### **ENVIRONMENTAL REVIEW**

The Project involves the repair and maintenance of existing public facilities (pedestrian trails), replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site as the structure replaced, minor alterations to land, and small habitat restoration with negligible or no expansion of use and therefore is exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines 15301(c), 15302, 15303, 15304(a), and 15333. A Notice of Exemption for the Project was prepared, approved by the Planning Director, and filed with the County Clerk prior to bidding.

#### **PUBLIC COMMENT**

As of the writing of this staff report, the City has not received any public comment. However, if staff receives public comment from interested parties following the publication and distribution of this staff report, such comments will

be provided to the City Council as supplemental materials before or at the meeting. In addition, public comments may be offered during the public comment portion of the agenda item.

#### **PUBLIC NOTICE**

This item was noticed in accordance with the Ralph M. Brown Act and was available for public viewing and review at least 72 hours prior to schedule meeting date. A condition of the City receiving and using Measure M Transportation funds for this Project, the Contractor will be required to post an informational board at the Project site during construction stating that Measure M is used to fund the Project.

#### FISCAL IMPACT

The adopted CIP Budget and the proposed budget amendment for the project are summarized in Table 2. The proposed budget amendment is an increase to the adopted budget by \$108,500.


Staff recommends the Sebastopol City Council, by minute order:
