INTRODUCTION/PURPOSE:

This item is to request that the City Council Consider the Request from Gregory Beale / The Beale Group for a Fee Deferral of the Art In Lieu Fee of \$33,000 for the Livery project at 6950 Burnett Street.

BACKGROUND:

The City of Sebastopol adopted an art requirement for new commercial and industrial construction projects that meet certain thresholds (\$1,000,000 for new construction and \$500,000 for renovations). In these instances, 1% of the construction cost must be dedicated to public art. There are two ways this can be done, one is by incorporating artwork into the project, which requires review and approval by the City's Public Art Committee (PAC) as appropriate to fulfill certain requirements (such as being in a public place, not part of the architecture, etc. See: https://sebastopol.municipal.codes/SMC/17.310). The other way to meet this requirement is by paying an 'in lieu fee' to the City. The City then uses this fee to support public art commissioned through the City's Public Art Committee process.

Application fees for City permits, applications and services are collected at the time an application is submitted. This includes the City's Art In Lieu fee, unless the applicant has received approval by the Public Art Committee for the on-site art. Any on-site art needs to be installed and dedicated by the time of final occupancy/final inspection, and must be maintained on the site (or the applicant may post a bond in the amount of the in-lieu fee at that time, reimbursable when the artwork is completed per Section 17.310.030(H)).

DISCUSSION:

The City of Sebastopol Design Review Board approved an application from Gregory Beale / The Beale Group for a major renovation of the building at 6950 Burnett Street on December 9, 2020 (File 2020-010). Since that time, the applicant has moved forward with building permits, which are now ready to issue. The applicant intends to develop on-site public art to meet the requirements of the City's Public Art ordinance (see letter attached) However, they have not yet developed the art work or submitted to the City. The applicant is requesting that the in-lieu fee be deferred at this time, and then intends to submit public art for approval by the PAC. This is similar to the process and request that was approved for the Hotel Sebastopol, which later submitted and received approval from the PAC for the on-site artwork.

Staff has reviewed the request and feels that this request is reasonable for several reasons. First, the construction project for the Livery project will allow enough time for review by the PAC of the artwork once developed if submitted in a reasonable time. Additionally, the Public Art Fund has a balance which is adequate for one to two additional commissioned artworks (generally in the \$30-45,000 range). These commissions generally take a couple of years, so even if the developer eventually pays a fee, it would not be needed for any anticipated PAC work in the next couple of years.

FISCAL IMPACT:

None. The value of the art, \$33,000, would either be provided on-site, or the fee would be due to the City prior to the building permit being finaled.

RECOMMENDATION:

Staff recommends the City Council approve the request from Gregory Beale / The Beale Group for a Fee Deferral of the Art In Lieu Fee of \$33,000 for the Livery project at 6950 Burnett Street and authorize the City Manager to execute any required documents.
