**INTRODUCTION:** This item is to request that the City Council Approve City Sponsorship for the Friends of

the Library Parking Lot Book Sales

#### **BACKGROUND:**

Friends of the Sebastopol Library is a volunteer non-profit organization that provides support to the Sebastopol Regional Library. While the Sebastopol Regional Library is a part of the Sonoma County Library system and is tax-supported, there are many items for which there are not enough tax dollars.

The majority of the funds raised by the Friends are through book sales. Friends volunteer almost daily to sort books and set up and staff the sales. Friends also volunteer time as needed to help the library.

# **DISCUSSION:**

The Friends of the Sebastopol Library sponsor programs such as Summer Reading, music performances, and holiday events. Funds from the Friends' book sales, membership dues, and donations enable the Friends to purchase books, equipment, and furnishings that are not available through the library budget.

A major event is the Book Sales conducted by the Friends of the Library. Typically the books sales are held within the library, but due to the COVID 19 pandemic, the group has had to look at alternate locations to hold their book sales to ensure the safety of the volunteers and the community. Tonight's item is to request approval of City sponsorship for the Friends of the Library Parking Lot Book Sales. The location is still to be determined but would be held on City property (city parking lot adjacent to the Library or Senior Center parking lot (area under their building). Both are City property and would require approval from the City. It is requested that the sponsorship include insurance coverage as this is a small group of volunteers who are key to helping to raise funds for the Sebastopol Library and do not have the required insurance as well as to provide minimal assistance with publicity: posting on the City's Facebook page, website and community newsletter; and placing flyers in the lobby at City Hall once it is open to the public.

#### **GOALS:**

This item relates to City Council Goal 5: Provide open and responsive Municipal Government Leadership; Goal 4 - Maintain and Enhance the City of Sebastopol as a Walkable/Bike-able Community and Enhance the City's Commitment to Promotion of our public's health by Creating and Participating in City and Community Programs, Services and Policies; 4.2. Foster a Sense of Community by Providing and Encouraging Participation in Community Events, Volunteering, and working with Non Profits to Support Local Events; 5.2. - Promote and enhance utilization of community energy and skills by creating opportunities for volunteer service.
