# INTRODUCTION/PURPOSE:

This item is to request that the Council Consider Appointment(s) as Council Liaison(s) to the Sebastopol Chamber of Commerce. (The Annual Committee Assignments where all Committees will be discussed will be at the January 16th 2024 City Council Meeting to allow for applications to be submitted to the Mayor for Recommendation Per the Council Process Established December 2022.

# **BACKGROUND:**

Each year, the City Council makes appointments to the various committees. Committees include:

1) City membership in a separate agency where the representative is a member of the governing board;

2) the City representative is a member of an advisory committee that makes recommendations to another public agency;

3) a Council member or Staff member is appointed as a liaison to a special committee;

4) other miscellaneous committees; and

5) Council created Ad Hoc or Standing Committees or Subcommittees

At the December 20, 2022 City Council Meeting, Mayor Hinton proposed a new process of appointments to the 2023 City Council and City Staff Committees. The Council approved the proposal as follows:

1. Mayor will send to all Councilmembers and Councilmember Elects, a copy of the Current City Council and City Staff Committee Assignments as well as an application that a Councilmember would fill out and return to the Mayor for consideration. A separate application would be required for each Committee that a Councilmember is interested in.

2. The Mayor would then review the applications submitted, speak with the Councilmember to obtain any additional information on their interest to serve on the committee, and provide a recommendation at the first meeting in January of each year of Council Committee Assignments. The Council would then be asked to approve/ratify the recommendations of the Mayor.

The applications will be sent out in the December timeframe with applications to be returned by January 1<sup>st</sup> to allow the Mayor at that time to review the applications and make recommendations to the City Council on all appointments.

However, due to the upcoming Board meetings for November and December, it is recommended that the Council discuss this item for appointment of Council Liaison(s). This item is similar in nature to the Budget Committee appointments made recently. Due to the request of a Committee to resign from the Committee, it was critical to ensure that the Budget Committee had members in place to address the financial crisis and direction of the City. As stated below, all Committees will be reviewed mid January.

# DISCUSSION:

The Sebastopol Chamber of Commerce is the business membership organization that connects the business community with ideas, inspiration and events to elevate collaboration and commerce, increasing economic vitality & vibrancy in the unique town of Sebastopol.

On October 30, 2023, City staff was informed that the Chamber had sent an email to the City Council requesting Council liaison(s) be appointed to attend Chamber Board Meetings as the meeting time had changed. With this change, it is difficult for the current primary liaison to attend the new date/times of the Board meeting. Due to the urgency of the request as the next Board meeting is scheduled for November 16<sup>th</sup> 2023 at 12:00 pm, it is recommended that the Council as a whole consider appointment for Council liaison(s) to the Chamber as the current liaison cannot attend these meetings going forward.

The meeting schedule for the Chamber is the Third Thursday of each month at 12:00 pm at the Chamber Office.

This would be similar to the Budget Committee representative appointed at the last City Council meeting where timing indicated an immediate appointment due to the financial crisis that the City is experiencing.
