**A. Sculpture Garden, 2<sup>nd</sup> call for submissions**

Discussion of music at the event. **Marghe** will see if a small classical music group is available through the Symphony Youth Orchestra.

Discussion of timeline plan for event. Music from 1PM to 2:30 PM with break for speeches. **Marghe** will manage this.

**Kari** will contact Jen Vertz about design of a 44X36 sign at the High St. entrance and have it made by the City. **Robert** offered to install the sign. A second smaller sign at the Ives Park end to be graphically identical and installed by the City.

**Jeff** volunteered to greet and liaise w/ artists as each arrives for the opening.
