## CITY COUNCIL PASSES RECREATIONAL VEHICLE PARKING ORDINANCE

In a special meeting on February 23, the Sebastopol City Council held a second reading of, and passed, an ordinance which prohibits parking recreational vehicles:

- on any public street in the city that is zoned residential at any time.
- on any public street in the city that is zoned commercial, industrial, or community facility at any time between the hours of 7:30am and 10:00pm.
- on any park, square, or alley at any time.
- in any city-owned parking lot at any time unless that person is conducting cityrelated business during business hours at the location for which the parking lot is designated.
- less than 30 feet from the corner of any street.

Exceptions are made for recreational vehicles parked:

- as a result of mechanical breakdown so as to allow the performance of emergency repairs on the vehicle for a period not to exceed 48 hours.
- on any public street in the city that is zoned residential so as to allow the use of a homeowner, tenant, or out-of-town visitor to load/unload the vehicle for a period not to exceed 72 hours.

The ordinance does not apply to commercial vehicles providing services to businesses, such as the delivery or picking up of goods or vehicles otherwise approved by other City of Sebastopol departments through that department's permitting process (e.g., construction vehicles).

The ordinance goes into effect on March 26, 2022. City Staff was directed to return to the Council with information on potential adjustments to the current 72-hour parking rule and to look at a possible permitting structure. The adopted ordinance will be available soon on the Municipal Code link on the City's website.



## SEBASTOPOL WALKS RETURN FEBRUARY 26 LEAD BY COUNCIL MEMBER SARAH GLADE GURNEY

Postponed during the pandemic, the 14-year strong Sebastopol WALKS program will return on February 26 with an easy 3 to 4-mile moderately paced "Peace Poles Potpourri" walk lead by Council Member Sarah Glade Gurney who said, "I've designed the first 2022 walk to be rich in geographic features, hidden treasures, visual delights, and fun community members. My RELAUNCH route, called "Potpourri," will encourage you to come walking again, in March and the months following, and to engage in our community in a new way, as we emerge from the pandemic. The "Hosts" lined up to speak at the 10 stops include both individuals and organizations that you'll want to know about. What a range! From our Poet Laureate to Buzzy, from Anne of the Laguna Foundation to Janet with an 'art-full' front yard! Warm up your boots. Join me for a fun premier walking tour "South of Bodega" in Sebastopol."



The walk starts at the Sebastopol Plaza at 9am and returns at about noon. Pre-registration is not required. Walkers will be encouraged to wear a face covering and maintain a six-foot distance, if desired. The program will be canceled upon direction from the City Manager/Attorney in the event CDC guidelines indicate.



Walks are scheduled for the last Saturday of the month through November. The events will vary in focus, length, and difficulty, based upon the routes chosen by the morning's leaders. See the <u>Sebastopol WALKS flyer</u> for a list of upcoming walks.

Some walks will be mainly for exercise to show participants how to connect places in town by foot and others will be informational. Some are new routes and new subject matter; others are updated versions of favorites.

The purpose of the WALKS program is to build interest in Sebastopol as a health-oriented community and help people experience the connectivity of our network of streets, sidewalks, paths, trails and alleys. Participants will learn that they can get around town wit hout driving their car and that they can enjoy the outdoors on foot. They will learn about Se bastopol's social, cultural, and political history as well as its municipal functions.

SEBASTOPOL ORGANIC COMPOST GIVEAWAY - MARCH 12TH



The Sebastopol Climate Action Committee is hosting an organic compost giveaway on Saturday, March 12th from 10am to 1pm. Home and school gardeners are in invited to come to the pick-up site with COVID safe masks, shovels, gloves, a tarp and a car with containers or a pick-up truck and load their free compost (email ahead of time if you need assistance with loading).

Free ½-1 Cu.Yd. per household - self serve, come prepared with shovels, gloves, mask, containers, or truck

Compost applied to garden beds and around trees will boost plants with nutrients, replenish the soil microorganisms and organic matter which in turn improves soil health and carbon sequestration. Healthy soil absorbs and retains water best which is super important during droughts.

- Healthy soil will require less irrigation during dry periods between rains.
- Healthy soil will absorb more water during heavy rains resulting in less runoff and erosion.


Home gardener Terri Moon happily reported, "After applying the compost from the Sebastopol fall give away I went from watering my garden every other day to watering once a week."
