Lowell Sheldon shall not exercise any personnel-related responsibilities in connection with the ownership, management, or operation of the subject business, including without limitation:

- (i) the hiring, training, management, supervision, review, discipline, or termination of any employee; or
- (ii) the fielding, review, investigation of, or response to any employee complaints or concerns.

Lowell Sheldon shall not undertake any work within the subject business premises during public hours unless required by unanticipated staffing shortages but then only provided that:

- (i) he exercises no managerial or supervisorial role, and
- (ii) at all times he refrains from consuming alcohol while working in any capacity.

Piala LLC shall engage and at all times retain an outside human resources firm to manage all aspects of employee complaints, issues, or concerns, including without limitation receiving, reviewing, investigating, and recommending appropriate action, if any, in response to such issues or concerns.

Kari,

To answer your questions, the key word regarding staffing shortages is "unanticipated." Vacations and personal days are planned; sick days where there's no staff coverage are "unanticipated." Finally if staff quits unexpectedly, Lowell may well have to substitute in until a new employee can be hired. The alternative may well be to shutter the restaurant which would be a commercially unreasonable consequence in such circumstances.

I would only add that after opening and managing a number of successful restaurants in the community, Lowell has little desire to work as a waiter, busser, or dishwasher. His filling in for any of those roles would certainly be as temporary as possible until new staff is hired. While there is presently a labor shortage, that's unlikely to continue indefinitely given the economic climate and further, given that Lowell's restaurants have always paid a living wage, Piala is more likely than other establishments to find new help sooner rather than later.

As for the owners of Piala, those are Lowell, Noah Chuma (who does not work in the restaurant industry and is a silent investor) and Jeff Berlin, who will be the on-site operations manager. The kitchen manager, Irma Hernandez, is not an owner.

Both Lowell and Jeff will address the Commission to explain their respective roles.
