INTRODUCTION:

This item is to request the City Council approve the purchase of a new Type 3 Wildland Fire Engine, replacing an aging and costly 1996 International Type 3 Wildland Fire Engine.

BACKGROUND:

Our current 1996 International Type 3 Wildland Fire Engine was purchased used from the Marin County Fire Department on February 28, 2014, for a bid price of \$12,000.00. We spent \$25,000.00 for necessary repairs and servicing. Key Auto Body of Sebastopol donated labor hours and paint and repainted the fire engine in June 2014. The Fire Engine went into Service in August of 2014 after receiving inspection and clearance from Cal Fire to be added to the State of California Mutual Aid System. We have been responding on Strike Teams to State Fires since 2014, including the Tubbs, Kincade, Walbridge, Glass, Nuns, Atlas, Pocket, Dixie, Monument, Caldor, and Fawn Wildland Fires. We have also Upstaffed here in Sonoma County during NWS Red Flag Warning Events throughout the years. Current mileage/odometer is 124,500 miles.

DISCUSSION:

Our current Type 3 Wildland Fire Engine has more than served its purpose for the Volunteer Firefighters of the Sebastopol Fire Department. We continue to have mechanical issues with costly repairs. Recently, we spent \$21,000.00 for repairs brought on by age and use. There is no air conditioning with this old fire engine, which today is a State of California requirement for the protection of the firefighters, when responding to and fighting our horrific wildland fires. The extreme heat within the cab of this fire engine has made the environment unhealthy and dangerous. The riding suspension is worn out and we are continually replacing front-end tie rods and tires. The engine has overheated during the intense heat of firefighting, threatening the lives of our volunteer firefighters. Our volunteer firefighters deserve better protection for their health and those that we are protecting. There are times during the initial fire attack that the firefighters are forced to sleep in the cab of the fire engine with an internal cab temperature of over 100 degrees. Fire Department Staff has solicited quotes from three Fire Engine Manufacturers to provide comparable quotes. Golden State Fire Apparatus for Boise Mobile Equipment (BME) submitted the lowest quote cost of \$386,327.00; their bid was considered complete and acceptable. The quote submitted by Golden State Fire Apparatus for Boise Mobile Equipment is based on Cal Fire State Bid Pricing, which has a built-in 15% discount.

Financing this purchase can be fulfilled by any the following methods:

A) Utilize the City Vehicle Replacement Reserve Fund. We are paid by the State and Federal Governments when deployed on Strike Teams. Our Fire Engines earned and received the following:

- B) Government Capitol Corporation (GCC) provides efficient, cost-effective municipal financing solutions. A 10-year term, low interest rates estimated at under 3%. The annual principal and interest payment would be approximately \$45,600. Total paid in principal (\$387,000) and interest (\$61,500) over the life of the loan \$448,500. Numerous Sonoma County Fire Departments have used GCC over the years.
- C) The Fire Department can coordinate with the Administrative Services Director to discuss financing options for this purchase through our local WestAmerica Bank and there's no guarantee that the interest rates would be less than 3%.

Please note, the projected delivery date for this Type 3 Wildland Fire Engine is 15-18 months from the time of the purchase order. Historically, the Sebastopol Fire Department has attempted to operate and maintain department vehicles on a 15-20 year useful lifespan replacement program goal.

GOALS:

Goal CSF 1: Provide High Quality Community Services, Facilities, and Infrastructure to All Residents, Businesses, and Visitors in Sebastopol.

PUBLIC COMMENT:

As of the writing of this staff report, the City has not received any public comment. However, if staff receives public comment from interested parties following the publication and distribution of this staff report, such comments will be provided to the City Council as supplemental materials before or at the meeting. In addition, a member of the public may speak on the consent calendar item or request at that time that an agenda item or items be removed for discussion.

FISCAL ANALYSIS:

Depending on which option below the City Council approves for this purchase, the budget impact will be as follows:

Option A:

Purchase Price for Replacement

Net General Fund Cost:

FY21-22 Approved Capital Budget: (124-31-02-5100) Approval for utilization of Reimbursement (104-31-02-3207) \$386,327.00 (\$40,000.00)

(\$295,310.00) \$51,017.00*

*The net General Fund Cost of \$51,017.00 can be covered by fund balance from the vehicle replacement reserve. As of June 30, 2021, the audited fund balance was \$1,221,288. We anticipate another busy year for the remainder of FY21-22 earning an additional \$100,000.00 to the City Vehicle Replacement Reserve Fund and that would result in a net gain to the City Vehicle Replacement Reserve Fund by approximately \$49,000.

If the City Council chooses Option A, a budget amendment of \$346,327 to increase Vehicle Replacement Reserve Fund account 104-31-02-5100 to pay for this purchase.

Option B: This option as mentioned above will be a debt service payment to the City that would be budgeted in FY22-23 through FY31-32 for approximately \$45,600 annually. This option would keep the Vehicle Replacement Reserve Fund intact at this time; however, this reserve fund can be utilized from year to year to pay for the debt service.

Option C: This option similar to Option B, would be a debt service payment and depending on the interest rate the bank will quote.

RECOMMENDATION:

That the City Council Approve, utilizing Option A under Fiscal Analysis, the Purchase of a New Type 3 Wildland Fire Engine to Replace the Existing 1996 International Type 3 Wildland Fire Engine.
