INTRODUCTION/PURPOSE:

This item is for City Council to Discuss and Consider Approval of Release of Flags Commemorating the 100th Anniversary of Women's Right to Vote to the Museum of the West Sonoma County Historical Society.

BACKGROUND:

In November 2019, the City Council approved a request for sponsorship of banners for the 100 Anniversary of Women's Suffrage. These flags were installed by the Boy Scout Volunteers and Former City Councilmember Michael Carnacchi on August 26, 2020.

Sebastopol displayed these flags in celebration of the 100 years of the passage of the 19th Amendment, Women's right to vote. You may notice gold-white-purple horizontal tricolor flags on Main St., which is the flag of the American suffrage movement.

Since then, the flags have been stored in the corporation yard at our Public Works Department. It is anticipated that the City doesn't have a future use for these flags while the WSCHS and Museum do, for their upcoming exhibit, publicity, and possible fundraising.

DISCUSSION:

The West County Museum on So. Main Street created an exhibit to honor the 100th anniversary but it was closed due to Covid-19. Donna Pittman, the Museum Director, hopes to open it once allowed.

I thought this would be an opportune time to release the flags to the Museum, for their anticipated re-opening of the Suffragist Exhibit, so I checked with Teresa Ramondo, Chair of WSCHS, and Donna Pittman, Museum Director, to see it they were interested. Donna replied as noted below:

Hi Sarah,

Teresa and I talked about this and she asked me to get back to you. We agree this is a great idea, and she will put on agenda with our Board for the Tuesday March 2 meeting. We'd like to discuss how best to put together an event..., especially in light of the fact that we might be getting close to a reopening with our Suffragist Exhibit. Perhaps we could coordinate something with that occasion.

We are excited about this idea and look forward to seeing it on the CC agenda.
