Subject: Approval of a Fee Waiver Request for \$1220 for Sebastopol Community Church for Micro

shelter Temporary Use Permit (1000 Gravenstein Hwy North)

INTRODUCTION/PURPOSE:

Applicant is requesting that the fee of \$1220 associated with the permitting process be waived by City Council.

BACKGROUND:

In 2021, the applicant applied for a Temporary Use Permit for a temporary residential use at their church site to install two pre-fabricated micro shelters in their parking lot for a period of up to 5 years. The Shelters are 60 square feet and large enough for one person or one couple. The shelters are also insulated and designed to protect the occupants from the weather. The units do not provide any water or electricity, but occupants will have access to limited church facilities. This project is designed to help with the homeless problem by providing two additional options for people in addition to the safe parking program the church already administers as part of their mission.

DISCUSSION:

The City of Sebastopol has an adopted policy to guide requests from non-profit organizations such as this, which was last adopted via Resolution 6439-2022, which allows City staff (department head approval of 25%, City Manager of 50%, but requires the City Council consider fee waivers beyond 50%, over \$1000, or for fees other than fixed fees. As this application is requesting the full (100% waiver) of a 'deposit account' fee (not a flat fee), and it is over \$1000, this request must be heard by the City Council.

Staff supports this waiver for several reasons. First, the organization is a qualifying non-profit providing a needed public service. The permit requested/approved by the Planning Commission supports several General Plan/Housing Element goals of the city (See below in Goals). Therefore, staff does not believe this would not be seen as a gift of public funds. Additionally, the amount of work for the project was not significant in terms of impact to the City's budget (the Planning Department can absorb these costs within its current operating budget).

GOALS:

This action supports the following City Council Goals

Goal 9 - Enhance housing opportunities in Sebastopol and, when possible, provide assistance to housing projects.

Policy D-2: The City will encourage the expansion of housing opportunities for extremely low income households.

Policy D-6: Sebastopol will work to prevent homelessness and support housing services for the homeless.

FISCAL IMPACT:

The City would lose \$1220.00 in fee revenue if this request is granted. However, this is likely less costly than public assistance to two additional homeless individuals/couples were these shelters not purchased /provided along with other social support services by the Church. No budget adjustment would be needed.

RECOMMENDATION:

Approve the waiver in the amount of \$1220 by minute order.
