Hi Mary,

The CAC recommendation is attached and summarized below:

- Recommend adoption of Tier 1 CalGreen Title 24
- Removal of potentially conflicting solar mandate (conflicts with state code)
- Provide space in future building code updates in the muni code for further organization of energy code subjects/elements

Attached is what the Climate Action Committee adopted as it's recommendation in relation to the Building Code updates at its October 12, 2022 meeting. This reflects the CAC recommendation to adopt Tier 1, and that we not pursue 'all electric' right now as we anticipate the State will be moving to this in 2026, and would be costly for us to do in advance of that right now.

The CAC also recommended that, at some point, the city move all of its code provisions regarding Green Building to the Muni Code as a separate chapter. The costs for this is somewhat prohibitive (estimated in the report at \$15,000) and not recommended. However, they did request that the chapter be created and items moved to that when updates are made. Steve attended this meeting and can provide further background if needed (I was not in attendance that day) at tomorrow's Council mtg.

I spoke with Steve Brown as well, he noted that the CalGreen Tier 1 is automatically adopted as part of this code cycle *unless a city specifically excludes it*, so that is included in his proposal.
