

**NOTICE OF PUBLIC HEARING**  
**CITY OF SEBASTOPOL**

Notice is hereby given that the City Council of the City of Sebastopol has scheduled a Public Hearing to consider revisions to the City's Municipal Code that would remove language that prohibits businesses that offer coin-operated play devices from serving alcohol on premises when minors are present. As noted below the following amendment to remove language from the City's Municipal Code will be considered:

- Chapter 5.58 Coin-operated Play Devices.
  - **5.58.100.A.10** No alcoholic beverages shall be sold or consumed on the premises, except those businesses where minors under the age of 21 are prohibited by law.
