A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEBASTOPOL AUTHORIZING A BUDGET AMENDMENT FOR BODEGA AVENUE BIKE LANES AND PAVEMENT REHABILITATION DESIGN (CIP PROJECT #0516-85.00)

WHEREAS, the City Council supports the proposal of the Budget Amendment for the Bodega Avenue Bike Lanes and Pavement Rehabilitation Design (CIP Project #0516-85.00); and

WHEREAS, to account for increase in the Fiscal Year 2020-21 Capital Improvement Program (CIP) expenditures, a \$270,000 corresponding budget adjustment is necessary for design, engineering, and project management of the project; and

WHEREAS, the funding source for the CIP project in the adopted Fiscal Year 2020-21 CIP budget assumed \$146,000 from CDBG grant funds, and \$50,000 from Traffic Impact Fees fund for a total funding amount of \$196,500 and is insufficient; and

WHEREAS, the CDBG grant was not awarded to the City and therefore CDBG fund source is not available for this project; and

WHEREAS, as reviewed by the Administrative Services Director, the following funding sources were identified and available for the increased expenditures as shown on the table.
