### INTRODUCTION:

This item is to request that the City Council Discuss and Consider Request to Broadcast, Videotape and Post to the City website the City Standing Budget Committee Meetings.

#### **BACKGROUND**

The underlying philosophy of California's open government laws is that public agency processes should be as transparent as possible. Such transparency is vital in promoting public trust in government. City processes should base on trust and confidence in the agency and demonstrate the agency's commitment to transparency. Openness, accountability and honesty are essential to build high levels of accountability and trust amongst citizens and enable fully informed engagement in the democratic process.

#### **DISCUSSION:**

It is the duty of local government to serve the public, reach its decisions, and conduct its activities in full view of the public. This is especially true for use of City funds. For communities to be able to work through City issues, especially a subject such as the City's complex and detailed budget, it is imperative that the Standing Budget Committee allow for broadcasting, taping and posting of the Budget Committee Meetings.

Information should be readily available; with exceptions for such items required under closed sessions. By broadcasting, video taping and posting the Budget Committee meetings to the City web site, this shows the City's commitment to transparency of discussions of the Budget Committee, demonstrates good governance, reassures the community that Budget Committee is discussing and recommending use for spending of public monies wisely; and increases the confidence and trust of the community.

#### Analysis:

Staff has reviewed the request and determined the following process could be utilized for Budget Committee Meetings:

- 1. Creation of In Person and Remote/Virtual Meeting Format
- 2. Use of Zoom for Public Participation During Meeting
- 3. Use of Live Stream to Stream Budget Committee Meetings to the Public

4. Posting of Video to City Web Site after the meeting by use of Link to Live Stream (Similar to Council Meetings)

### Staff Time Involved:

The Administrative Services Director who will initiate all of the budget meeting will also record the meetings. After each meeting, the zoom file to be uploaded to livestream where all the meetings are hosted. Depending on the duration of each budget meetings, it might take 48 hours before a meeting will be available and posted on the City website.

It is proposed that the closed caption feature of Zoom and raw text be utilized for rough minutes but should not be relied upon as the official documentation of the meeting. The City video will be the official record of the meeting and will be available for a period of one year per the City's records retention schedule.
