INTRODUCTION: This item is to request City Council Approve the Resolution and Authorize Amendment to the Contract for Relaunch Sebastopol from \$146,000 to \$118,000. This will be a reduction in the contract of \$27,500. The reduction would also result in a reduced scope of work. If approved, the unspent funds will be returned to the General Fund.

BACKGROUND:

On October 19, 2021 the City Council approved a Request for Proposals (RFP) for a Relaunch Sebastopol contract to manage and coordinate a variety of organizations and interests towards a common goal of increased community vitality. The Council authorized \$86,000 for this contract and an additional \$10,000 for insurance costs to Townie Media to develop and sustain a strong local economy to provide business and residents with, among other things, the necessary municipal services to maintain the community's high quality of life. Townie Media was hired to carry out the tasks in the RFP to enhance community and economic vitality for Sebastopol and coordinate a variety of organizations and interests towards a common goal of increased community vitality. The Sebastopol City Council granted Townie Media an additional \$50,000 and a three-month extension on the Relaunch Sebastopol contract for a term ending date of June 30, 2023.

DISCUSSION:

The Ad Hoc Committee for Relaunch Sebastopol has been meeting with Relaunch Sebastopol Consultant to provide a plan to carry out the tasks in the RFP to enhance community and economic vitality for Sebastopol and coordinate a variety of organizations and interests towards a common goal of increased community vitality.

The Council has received informational reports from Relaunch Sebastopol's consultant, Laura Hagar, on work completed since the execution of the contract in response to the tasks in the RFP: fostering business development; attracting consumers to visit; promoting Sebastopol as a great place to live, work and visit; encouraging existing property owners to reinvest in their buildings; creating a "City day" picnic for the community to bring businesses and community together or utilizing empty businesses to create "pop up" events; and working with the local schools for community hour projects to beautify the City (Park/Street clean up, murals on benches/garbage cans, painting of City light poles, etc.).

As part of the Ad Hoc Committees, the Committee and Consultant have discussed the tasks and priorities and how it relates to the contract as well as the City's current budget and proposed DRAFT FY 23 24 City budget. In light of the current fiscal projections, the committee and consultant met and mutually agreed that amending the budget to reduce costs would be beneficial to both the City and consultant but still continuing to provide the Visit Sebastopol website to promote Sebastopol as a great place to live, work and visit, updating and maintaining the business directory and business page on the City web site; and also maintain and updating of the community calendar for residents and visitors. Any remaining scope of work would be removed from the current contract.

The item tonight is to recommend that the Council consider the request to reduce the budget and scope of work for Relaunch Sebastopol with the priority of maintaining the Visit Sebastopol website and community calendar through June 2023 which is the ending date of this contract.

Separate discussions with City staff and budget committee will address the future of the Visit Sebastopol website and community calendar.
