## INTRODUCTION/PURPOSE:

This item is to request City Council to approve the attached Resolution declaring weeds growing upon private properties within the City a fire hazard and a public nuisance and set a public hearing date on June 6, 2023 for those who object to the proposed removal of weeds from their lots.

#### **BACKGROUND:**

Every year a number of private properties are declared to be a fire hazard, therefore a public nuisance and in need of abatement. The resolution is passed and adopted, and a date set for a public hearing for those owners who object to this resolution. The hearing date will provide us sufficient time to legally notice all of the affected property owners of the public hearing. This is an annual program for weed abatement in the City. City Ordinance #647 provides for an abatement procedure and hearings.

## **DISCUSSION:**

The attached Resolution signifies the beginning of the City's Annual Weed Abatement Program. The Resolution declares weeds a public nuisance and sets a date for public hearing in order to provide property owners a means of protesting the removal of weeds on their property.

The parcels of land listed on Exhibit "A" (attached) have been inspected and, at that time of inspection, were found to have weeds thereon. These weeds have the potential to become a fire hazard in the very near future as summer weather patterns cause the weeds to become dry and combustible.

If the weeds on these parcels are not removed by June 15th, 2023, the City will abate the fire hazards and bill the property owners for the cost of abatement plus administrative costs.

There is no fiscal impact with this item tonight; however, if the property owner fails to abate their lots, a contractor hired by the Fire Department will abate the lots and the property owner will be billed for the cost of abatement plus administrative costs.

That the City Council adopts the attached Resolution in order to proceed with the City's Weed Abatement Program.

RESOLUTION DECLARING WEEDS ON PRIVATE PROPERTY TO BE A PUBLIC <u>NUISANCE IN</u> <u>ACCORDANCE WITH ORDINANCE #647</u>
WHEREAS, the Fire Chief has reported that certain owners of properties have not abated and removed weeds and other fire hazards from their property, and
WHEREAS, Ordinance #647 provides for an abatement procedure and hearing,
NOW THEREFORE, BE IT RESOLVED that the weeds on properties listed on the attached Exhibit "A" are hereby declared to be a Public Nuisance, and
BE IT FURTHER RESOLVED that a hearing is hereby set for 6:00 p.m., June 6th, 2023 to hear any objections to the proposed destruction and removal of said Weeds and Fire Hazards; and that the expense thereof shall be assessed upon the lot or lands from which such weeds shall have been destroyed or removed.
