5. REGULAR AGENDA:

A. Election of Chair

Chair Mills-Thyssen announced her resignation as Chair. Chair Mills-Thyssen nominated Robert Brent as Chair. Harris seconded the motion. Motion passed 4-0-1, with Harris, Stucker, Mills-Thyssen, and Langberg voting 'yes' and Brent abstaining.

B. Ned Kahn Sculpture Update

Director Svanstrom provided an update and current schedule.

C. Sculpture Garden Submission Review

Director Svanstrom provided an update.

Vice Chair Stucker moved and Chair Brent seconded to deny the piece by Mirka Knaster "Wheels of Peace". Motion passed 4-1, with C. Harris `no'.

Vice Chair Stucker moved to have PAC contact the artist to discuss next steps. Mills-Thyssen seconded. Motion was withdrawn by VC Stucker

Chair Brent moved to reconsider the motion to deny the application. Mill-Thyssen seconded. Motion passed unanimously, denial is rescinded.

Concerns included size and how it would be arranged on the sculpture garden site, durability of materials, and a few others.

Chair Brent moved that we contact the artist directly to discuss specifications and concerns before a vote to accept or deny the application. VC Stucker seconded the motion. PAC discussed. Motion passed unanimously. Robert and Jeff to meet with artist on the site; Jeff to contact.

Robert Michael Smith submission:

PAC discussed. Langberg made motion to accept piece with the condition that the base be resolved when installed. Mills-Thyssen seconded. Motion passed unanimously. Robert Brent to coordinate with artist.

Peter Crompton / Robin Crompton Submissions: VC Stucker moved and Mills-Thyssen seconded top accept Nautilus sculpture for garden. Motion passed unanimously.

Chair Brent moved to accept Cassandra with pythons and work with the artists to ; Harris seconded. Brent amended that if the pythons don't work, that we accept the Cassandra piece alone. Motion passed unanimously.

VC Stucker made a motion to accept the poodle for the CSG. No second, motion failed. Chair Brent moved to deny the poodle application, Harris seconded. 4-1 denied, with VC Stucker a 'no'.

The Committee discussed this item; no formal action was taken.
