**Subject:**               Approval and Receipt of Upcoming Openings on the Design Review Board for term of Dec 31, 2024, through Dec 31, 2026

**RECOMMENDATIONS:**

That the City authorize City Staff to notice and recruit for upcoming openings on the Design Review & Tree Board (DRB).

**EXECUTIVE SUMMARY:**

The Design Review & Tree Board has three out of six terms ending on December 31<sup>st</sup>, 2024. City Staff would like to open recruitment for these upcoming openings and ensure a smooth transition at the first Design Review Board/Tree Board Meeting of January 2025.

The City Council will be discussing the potential restructuring on the Design Review & Tree Board and the Planning Commission during a meeting in the near future, and with that staff recommends that the council open recruitment for the Design Review & Tree Board until a final decision is made next calendar year.

**BACKGROUND AND DISCUSSION:**

The Design Review & Tree Board was created by the City Council. The Design Review & Tree Board terms are two years and will be until December 31<sup>st</sup>, 2026. Listed below are the upcoming openings:

- a) Upcoming Openings on the Design Review & Tree Board (DRB)
  - Term Ending Dates:               December 31, 2024
  - i.   Cary Bush                       Category A (licensed architect)
  - ii.   Lynn Deedler                Category B (architect, designer, contractor)
  - iii.  Marshall Balfe              Category D (alternate)

The Board shall consist of five members and the City Council shall select, if possible, the following:

- A. Two persons, at least one of whom shall be a licensed architect and at least one of whom shall be a licensed landscape architect.
- B. One person who may be any of the following: architect, landscape architect, building designer, building contractor, landscape contractor.
- C. Two persons not in subsection A or B of this section.
- D. One alternate who may be in subsection A of this section or who possesses a particular expertise in the area of design, land use patterns, urban development or other related fields to serve at any meeting or on any matter in the absence of a Board member, or in the event a member has a conflict of interest.
- E. In the event suitable candidates satisfactory to the City Council in the above categories are not available to serve, the City Council may then select any person or persons in their discretion. All terms of office shall terminate December 31<sup>st</sup> of the last year of the term of appointment.

City Staff will initiate the public application process for the upcoming openings. Applications will be available on the City website and at City Hall. Notice of the openings will be published and the application period will be open for approximately six weeks. Staff would agendize the interviews and appointments for a future City Council meeting after the application deadline.

**STAFF ANALYSIS:**

That the City Council authorize recruitment for the upcoming openings.

**COMMUNITY OUTREACH:**

This item has been noticed in accordance with the Ralph M. Brown Act and was available for public viewing and review at least 72 hours prior to schedule meeting date.
