Dear Mayor Rich, Vice Mayor Zollman, and Council Members,

I am writing to encourage you to approve consent calendar item 4, the Resolution calling for a ceasefire in Gaza as submitted.

In doing so, Sebastopol will be joining the California cities of Long Beach, San Francisco, Oakland, Richmond, Cudahy, Madera, and a growing number of others in calling for an immediate ceasefire. It will also be joining the United Nations, Amnesty International, the World Health Organization, world leaders, religious leaders, and citizens of the world everywhere in calling for an immediate and permanent ceasefire and the prompt release of all hostages on both sides.

Sebastopol has a long record of rightfully weighing in on state, national, and international issues in instances where events of significant human rights, social justice, and moral obligation compel our elected leaders to represent the sentiments of constituents in the form of a formal Resolution. The death and destruction underway in Gaza is such an instance.

The British Red Cross has stated that "It's projected that the entire 2.22 million population of Gaza is now experiencing food insecurity at crisis levels or above. This is the highest share of a population facing high food insecurity that has ever been classified by the Integrated Food Security Phase Classification anywhere in the world."

On February 14, Martin Griffiths, The UN under-secretary-general for humanitarian affairs stated that "*Gaza is the worst humanitarian crisis I have seen in 50 years*."

This is not a matter of who did what when, it is now a matter of doing whatever is possible at this time to save lives. If it were Jews or any other ethnicity or race being bombarded and starved, I would be calling for a ceasefire.

Supporting a ceasefire in Gaza is not only a moral imperative but also a practical necessity for the well-being and stability of the region and beyond. The ongoing bombing of Gaza has resulted in immense human suffering, with civilian casualties, including thousands of women and children. A ceasefire will halt the bloodshed and provide much-needed relief to the innocent civilians caught in the crossfire.
